JOINT RESOLUTION

At the regular meeting of the Village Council of Bagley, Minnesota, held concurrently with a special meeting of the Town Board of Copley Township, Clearwater County, Minnesota, on November 7, 1973, Councilman Hanson of the Village of Bagley and Supervisor Janous of Copley Township introduced the following resolution and moved its adoption:

WHEREAS, The Village of Bagley has an application pending and has been assured of federal financial assistance in extending its sewer and water facilities to the area hereafter described, and

WHEREAS, The territory described abuts upon the Village limits of Bagley, Minnesota, and none of it is presently included within the corporate limits of any other incorporated city, village or borough, and

WHEREAS, The following described area <sup>is</sup> is or/about to become urban or suburban in character, and

WHEREAS, The Village of Bagley and the Township of Copley wish to designate the following described area, to-wit: The West Half of the Northeast Quarter (W $\frac{1}{2}$ NE $\frac{1}{4}$ ), the Northwest Quarter (NW $\frac{1}{4}$ ), and the North <sup>H</sup>alf of the Southwest Quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$ ), all in Section Thirty (30), Township One Hundred Forty-seven (147) North, Range Thirty-seven (37) West, of the Fifth P.M., as an area that is in need of orderly annexation under Minnesota Statutes 414.032.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF BAGLEY, MINNESOTA, AND THE TOWNSHIP OF COPLEY, CLEARWATER COUNTY, MINNESOTA, that the Minnesota Municipal Commission take jurisdiction over the annexation of the above described area pursuant to M.S.A. 414.032; and

BE IT FURTHER RESOLVED, That the Village Clerk of Bagley, Minnesota, and the Town Clerk of Copley Township are hereby authorized and directed to transmit certified copies of this resolution to the Minnesota Municipal Commission.
