A RESOLUTION DESIGNATING UNINCORPORATED AREAS AS IN
NEED OF ORDERLY ANNEXATION AND CONFERRING JURISDICTION
OVER SAID AREAS TO THE MINNESOTA MUNICIPAL COMMISSION

WHEREAS, Certain properties within the Township of Lake Marshall are in need
of orderly annexation to the City of Marshall; and

WHEREAS, The properties are located in the County of Lyon and State of Minnesota
and described as follows, to-wit:

The South 742 feet of the North 1,318 feet of the East
324.5 feet of the West 368.41 feet of the Northwest Quarter
of the Southeast Quarter of Section 8, Township 111 N, Range 41W.

The West 300 feet of the East 1,000 feet of the North 580 feet
of the Northeast Quarter of the Southwest Quarter of Section 2,
Township 111N, Range 41W.

A tract of land located in the Northeast Quarter of Section 10,
Township 111 North, Range 41 West, Lyon County, Minnesota, being
more particularly described as follows:

Beginning at the North Quarter Corner of said Section 10;
thence South 89°35'27" East, assumed bearing, along the
North line of said Northeast Quarter 250.00 feet; thence
South 00°00'00" East 90.54 feet; thence South 56°28'27"
West 299.88 feet to a point on the West line of said North-
east Quarter; thence North 00°00'00" East along said West
line 257.95 feet to the point of beginning.

WHEREAS, Said properties are within the orderly annexation area agreement
contained in Resolution No. 1283, dated March 4, 1976, between Lake Marshall
Township and the City of Marshall; and on file with the Minnesota Municipal
Township and the City of Marshall; and on file with the Minnesota Municipal
Commission;

NOW, THEREFORE, BE IT RESOLVED, That upon the adoption of this Resolution by
the Common Council of the City of Marshall, jurisdiction over annexation of
the above described areas be conferred to the Minnesota Municipal Commission,
pursuant to M.S.A. 414.032.

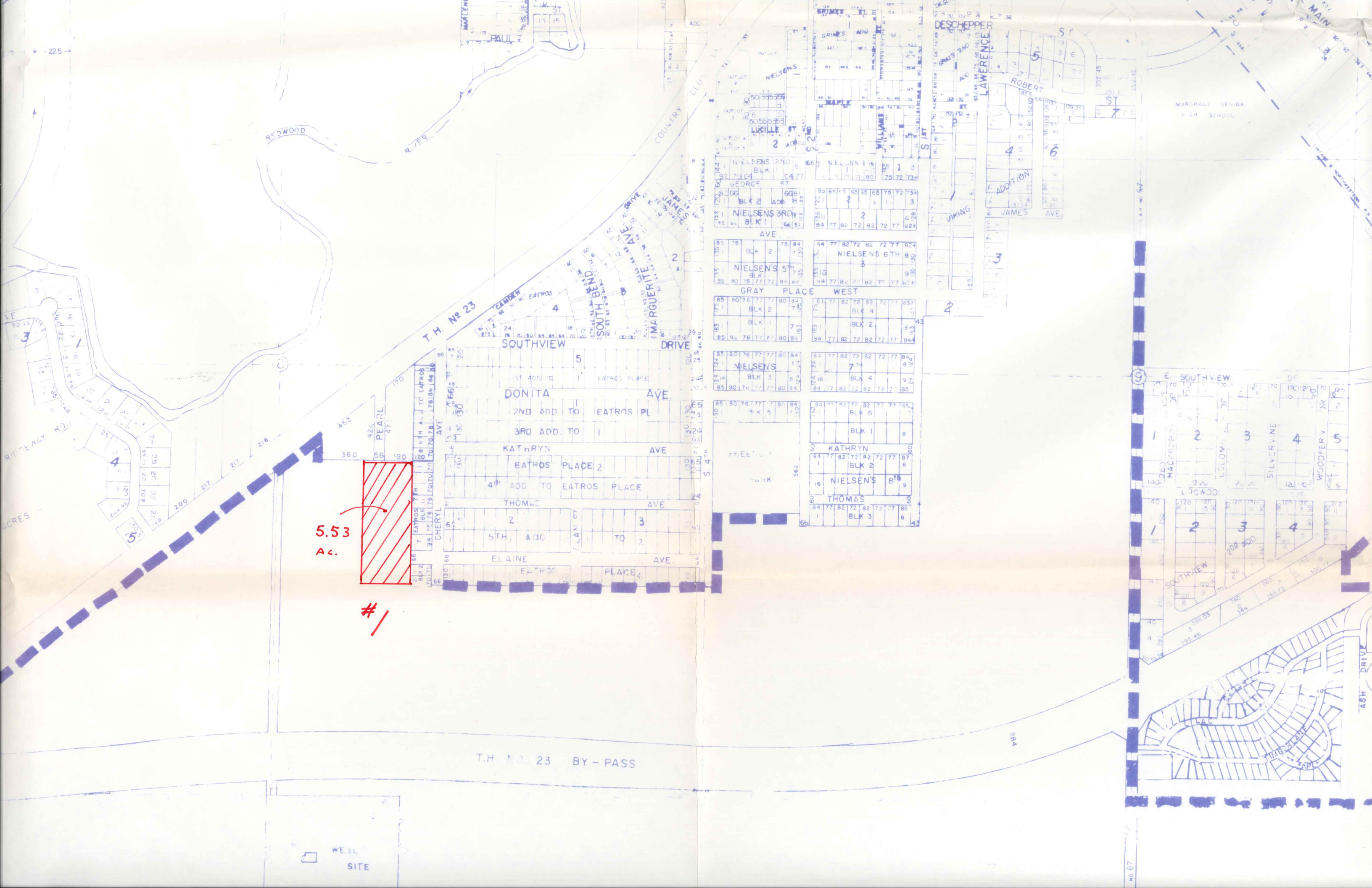

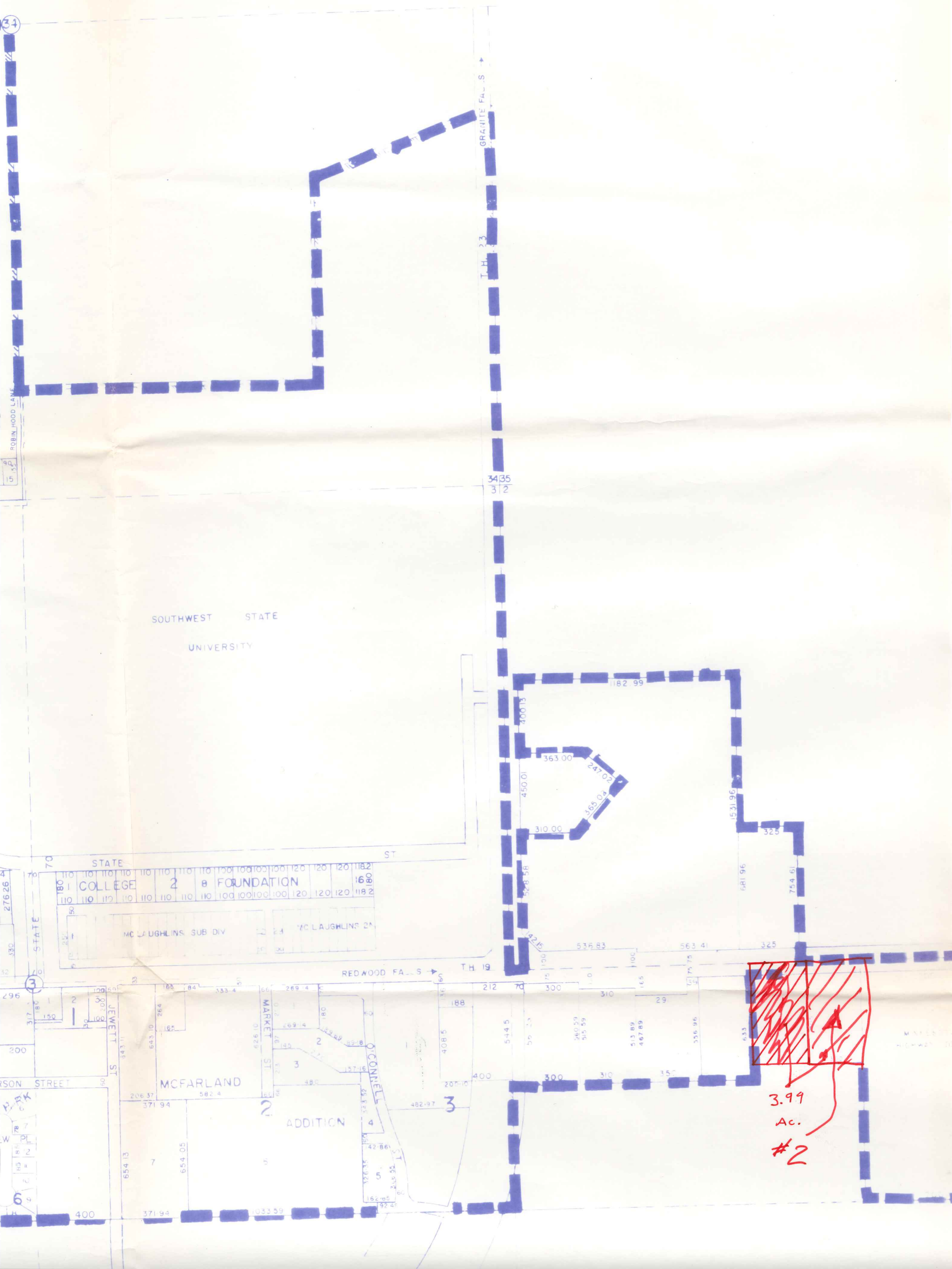

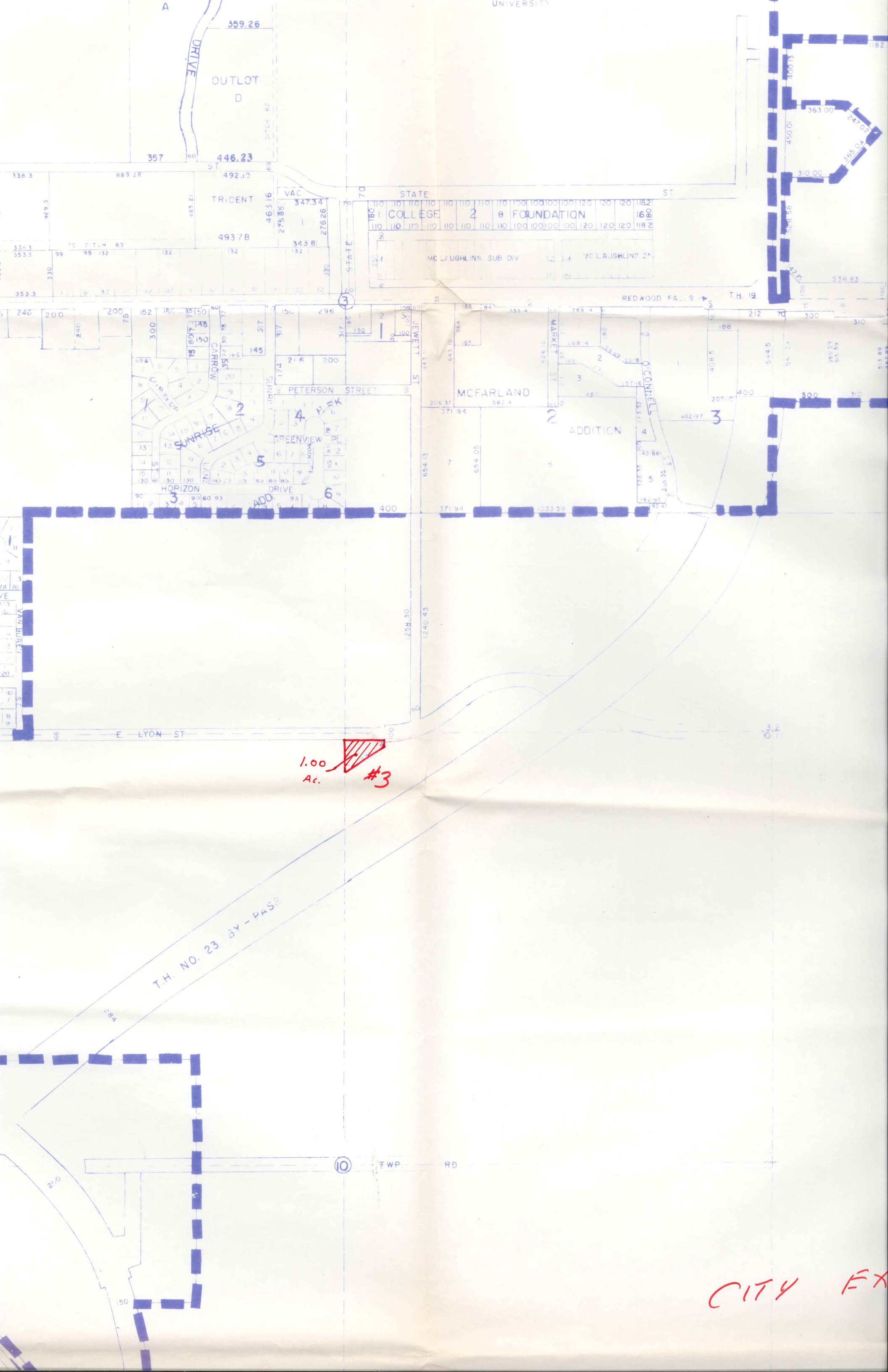
