1. That the following described area in Cokato Township is subject to Orderly Annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for orderly annexation, to wit:

PARCEL A

The Northwest Quarter of the Southeast Quarter of Section 27, Township 119, Range 28 West Except: The North 100 feet of said Northwest Quarter of the Southeast Quarter, Wright County, Minnesota (Area of 35.62 acres.

Subject to public road easement restrictions and reservations of record, if any.

AND

PARCEL B

The North 100 feet of the Northwest Quarter of the Southeast Quarter of Section 27, Township 119, Range 28, Wright County, Minnesota (area 3.02 acres)

Subject to public road easement restrictions and reservations of record, if any.

- 4. Upon annexation, the property to be annexed will become urban and suburban in character.
- 5. Both the Township of Cokato and the City of Cokato agree that no alternation of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no other consideration by the Municipal Board of Adjustments is necessary. Upon receipt of this Resolution, passed and adopted by each party, the Municipal Board of Adjustments may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.



The Northwest Quarter of the Southeast Quarter of Section 27, Township 119 North, Range 28 West, Wright County, Minnesota. Except:


The north 100 feet of said Northwest Quarter of the Southeast Quarter.
