AGREEMENT BETWEEN THE CITY OF BUFFALO)	<u>O R D E R</u>
AND THE TOWN OF BUFFALO PURSUANT TO)	
MINNESOTA STATUTES 414)	

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Buffalo and the Town of Buffalo and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Buffalo and the Town of Buffalo indicating their desire that certain property be annexed to the City of Buffalo pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on November 21, 1988, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property located in Buffalo Township, Wright County, Minnesota, is hereby annexed to the City of Buffalo, Minnesota, the same as if it had originally been made a part thereof:

8th Street Northwest

No. 1 - The north 33.00 feet of Lots 12 through 17, Auditor's Subdivision No. 3, according to the plat thereof on file and of

record in the office of the County Recorder, Wright County, Minnesota, except that part platted as CARNEGIE ACRES, according to the plat thereof on file and of record in the office of the County Recorder, Wright County, Minnesota.

No. 2 - All that part of the platted Eighth Street Northwest in CARNEGIE ACRES, according to the plat thereof on file and of record in the office of the County Recorder, Wright County, Minnesota.

No. 3 - The north 33.00 feet of the west 73.30 feet of Lot 18 and the north 33.00 feet of the east 84.00 feet of Lot 19, Auditor's Subdivision No. 3, according to the plat thereof on file and of record in the office of the County Recorder, Wright County, Minnesota.

No. 4 - The south 33.00 feet of the Southwest Quarter of the Southwest Quarter of Section 19, Township 120, Range 25, Wright County, Minnesota, except the west 653.47 feet thereof.

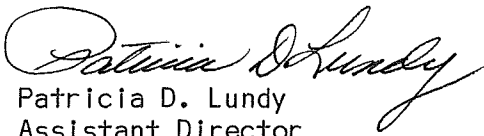

No. 5 - The westerly half of Wright County Highway Number 114 that lies within the south 459.26 feet of the north 1100.00 feet of the North Half of the Northeast Quarter of Section 19, Township 120, Range 25, Wright County, Minnesota.
