

A RESOLUTION TO ANNEX CERTAIN ADJOINING UNINCORPORATED
TERRITORY TO THE CITY OF FERGUS FALLS, MINNESOTA

TO THE MINNESOTA MUNICIPAL BOARD:

WHEREAS, The City of Fergus Falls and the Township of Fergus Falls entered into an orderly annexation agreement on the 2nd day of May, 1974, wherein certain lands were designated as in need of orderly annexation; said agreement conferred jurisdiction of said described areas to the Minnesota Municipal Board; and,

WHEREAS, The tract of land described below abutts on the city limits at its northeasterly boundary thereof and said area is or is about to become urban or suburban in character.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FERGUS FALLS:

1. The City Council hereby determines

A. That annexation of the territory described in Section 2 will be to the best interests of the City and of the Territory affected.

B. That the Territory abutts the city limits and is or is about to become urban or suburban in character.

C. That the City is able to provide the necessary municipal services required by the area within a reasonable time.

D. That none of said territory is now included within the limits of any city, village or borough.

2. The City Council hereby declares its intention to annex the following territory to the City of Fergus Falls:

The Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) and the East Half (E $\frac{1}{2}$) of Section Twenty-five (25), Township One Hundred Thirty-three (133) North, Range Forty-three (43) West, not presently within the City of Fergus Falls.

3. A corporate boundary map upon which is delineated the proposed boundary adjustment is hereto attached and marked Exhibit "A" and made a part of this resolution.

4. The names of all parties entitled to notice pursuant to M.S.A. 414.09 are as follows:

- (1) Town of Fergus Falls, Otter Tail County, Minnesota
- (2) City of Fergus Falls, Minnesota
- (3) County of Otter Tail, Minnesota
- (4) City Planning Commission, City of Fergus Falls, Minnesota
- (5) Otter Tail County Planning Commission, Otter Tail County, Minnesota

5. The City Administrator be and he hereby is directed to serve certified copies of the within Resolution upon the parties entitled to notice and after said parties have received notice, the City Administrator shall file the within resolution with the Minnesota Municipal Board and request that the Secretary of said Board set a time and place for hearing on this resolution in accordance with Minnesota Statutes 414.032 and 414.09.

The above and foregoing resolution was offered at a meeting of the City Council of the City of Fergus Falls on the 5th day of January, 1981, by Alderman Larson who moved its adoption and was seconded by Alderman Odenkamp and was adopted by the following vote:
