ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of St. Cloud and the Town of St. Augusta; and

WHEREAS, an amendment to the joint resolution was received from the City of St. Cloud and the Town of St. Augusta requesting that certain property be annexed to the City of St. Cloud pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325, M.S. 414.11, and M.S. 414.12 states that in certain circumstances the Director of the Office of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on April 14, 2000, the Director of the Office of Strategic and Long Range Planning has reviewed and accepted the amended joint resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property, except areas previously annexed into St. Cloud, is hereby annexed to the City of St. Cloud, Minnesota, the same as if it had originally been made a part thereof:


Beginning at the point where the east right-of-way of Highway 152 intersects with the north boundary of St. Augusta Township; thence south along said east right-of-way to the point of intersection with the east boundary of the east right-of-way of Interstate Highway 94;

thence south along said east right-of-way of Interstate 94 to the point of intersection with the south line of the SE 1/4 of the NW 1/4 of Section 18, T 123 North, R 27 West; thence east along said south line to a point 109.4 feet east of the southwest corner of the SE 1/4 of the NE 1/4; thence north 109.4 feet distant and parallel with the west line of said SE 1/4, NE 1/4 to its north line; thence easterly along said north line to the east line of Section 18; thence north to the northeast corner Section 18; thence continuing north, along the west line of Section 8, on an assumed bearing of North 0 degrees 29 minutes 20 seconds west to the southwest corner of Government Lot 2; thence North 88 degrees 24 minutes 46 seconds east 759.96 feet; thence North 46 degrees 22 minutes 28 seconds east, 780 feet, more or less, to a point in the east line of said Government Lot 2; thence north along said east line to the point of intersection to the thread of the Mississippi River; thence north along said thread to the point of intersection with the north boundary of St. Augusta Township; thence west along said north boundary to the point of beginning.

IT IS FURTHER ORDERED: That the effective date of this order is April 14, 2000.
