AMENDMENT TO THE JOINT RESOLUTION FOR
ORDERLY ANNEXATION BETWEEN THE TOWN OF
ST. CLOUD AND THE CITY OF ST. CLOUD


The Township of St. Cloud and the City of St. Cloud are parties to a Joint Resolution as to Orderly Annexation dated August 19, 1974. The City of St. Cloud has received a petition in accordance with paragraph #4 of the Joint Resolution whereby petitioners requested annexation of lands in the orderly annexation area. The petitioners represented seventy (70%) percent of the ten (10) property owners of the lands proposed to be included under their petition. The Township of St. Cloud and the City of St. Cloud hereby jointly agree that the Orderly Annexation Agreement dated August 19, 1974, be amended as follows:


Both the Town and the City agree that the following described area within the lands presently designated for orderly annexation be annexed to the City of St. Cloud, to-wit:

Lots Two (2), Three (3), Four (4) and Five (5) in Block Three (3) and Lots Ten (10), Eleven (11), Twelve (12), Thirteen (13), Fourteen (14), Fifteen (15) and Sixteen (16) in Block One (1), Holy Spirit Addition, Stearns County, Minnesota including adjoining street right-of-way and all that part of the street right-of-way lying North and West of the Lot Sixteen (16).

Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of this amendment, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation of the above described property, which property is shown on the map attached hereto as Exhibit A and made a part of this amendment.




