AMENDMENT TO THE JOINT RESOLUTION FOR
ORDERLY ANNEXATION BETWEEN THE TOWN OF
ST. CLOUD AND THE CITY OF ST. CLOUD

The Township of St. Cloud and the City of St. Cloud are parties to a Joint Resolution as to Orderly Annexation dated August 19, 1974. The City of St. Cloud has received a petition in accordance with paragraph #4 of the Joint Resolution whereby petitioners requested annexation of lands in the orderly annexation area. The petitioners represented one hundred (100%) percent of the property owners of the lands proposed to be included under their petition. The Township of St. Cloud and the City of St. Cloud hereby jointly agree that the Orderly Annexation Agreement dated August 19, 1974 be amended as follows:

Both the Town and the City agree that the following described area within the lands presently designated for orderly annexation be annexed to the City of St. Cloud, to-wit:

That part of Lot Numbered One (1), in Block Numbered Three (3) in Holy Spirit Addition, a platted subdivision in the Town of St. Cloud, according to the plat and survey thereof on file and of record in the Office of the Register of Deeds in and for the County of Stearns and State of Minnesota, described as follows, to-wit: Commencing at the Northwest corner of Lot One (1) in Block Three (3) and running thence due East along the North line of said Lot One (1) for 183.8 feet; thence due South parallel with the East line of said Lot One (1) for approximately 75 feet to the South line of Lot One (1); thence West for 154.20 feet along the South line of Lot One (1) to the Southwest corner of Lot One (1); thence in a Northwesterly direction for 80.25 feet along the Northwest line of Lot One (1) to the point of beginning, and there terminating; together with the South One-Half (S 1/2) of 22nd Street South adjacent thereto.

Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of this amendment, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation of the above described property, which property is shown on the map attached hereto as Exhibit A and made a part of this amendment.
