AGREEMENT BETWEEN THE CITY OF ST. CLOUD)	<u>ORDER</u>
AND THE TOWN OF ST. CLOUD PURSUANT TO)	
MINNESOTA STATUTES 414)	

WHEREAS, a joint resolution for orderly annexation was adopted by the City of St. Cloud and the the Town of St. Cloud and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of St. Cloud and the Town of St. Cloud indicating their desire that certain property be annexed to the City of St. Cloud pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 1, 1988, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of St. Cloud, Minnesota, the same as if it had originally been made a part thereof:


That part of Lot Numbered One (1), in Block Numbered Three (3) in Holy Spirit Addition, a platted subdivision in the Town of St. Cloud, according to the plat and survey thereof on file and of record in the Office of the Register of Deeds in and for the County of Stearns and State of Minnesota, described as follows, to-wit: Commencing at the Northwest corner of Lot One (1) in Block Three (3) and running thence

due East along the North line of said Lot One (1) for 183.8 feet; thence due South parallel with the East line of said Lot One (1) for approximately 75 feet to the South line of Lot One (1); thence West for 154.20 feet along the South line of Lot One (1) to the Southwest corner of Lot One (1); thence in a Northwesterly direction for 80.25 feet along the Northwest line of Lot One (1) to the point of beginning, and there terminating; together with the South One-Half (S1/2) of 22nd Street South adjacent thereto.

IT IS FURTHER ORDERED: That the effective date of this order is March 1, 1988.
