WHEREAS, a joint resolution for orderly annexation was adopted by the City of Lindstrom and the Town of Chisago Lake; and

WHEREAS, a resolution was received from the City of Lindstrom and the Town of Chisago Lake indicating their desire that certain property be annexed to the City of Lindstrom pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, Reorganization Order No. 192, effective March 8, 2005, has transferred the duties of the Director to the Chief Administrative Law Judge.

WHEREAS, on January 11, 2006, the Chief Administrative Law Judge reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Lindstrom, Minnesota, the same

as if it had originally been made a part thereof:

Parcel 1:

That part of the South Half of the Northeast Quarter and all that part of the Southeast Quarter of the Northwest Quarter lying East of Lincoln Road (County State Aid Highway No. 14), all in Section 29, Township 34, Range 20, and lying Southeasterly of the following described line:
