IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Spring Valley, Minnesota, the same as if it had originally been made a part thereof:

That part of the Northeest Quarter of the Northwest Quarter (NE 1/4 NW 1/4) of Section 28, Township 103 North, Range 13 West, Filmore County, Minnesota, described as follows: Beginning at the Northeast Corner of said NE 1/4 NW 1/4; thence North 89 degrees 58 minutes 01 seconds West (assumed bearing) along the North line of said NE 1/4 NW 1/4, 740.45 feet to the canterline of the Spring Valley - Hamilton Tentional Road (formally a Township Road); thence South 18 degrees 27 minutes 20 seconds East along said centerine, 1091.90 feet; thence North 77 degrees 39 minutes 54

seconds East, 405.19 feet to the East line of said NE 1/4 NW 1/4; thance North 00 degrees 03 minutes 47 seconds West along said East line, 948.75 feet to the point of beginning and containing 13.11 acres, more or less. Subject to easement for C.S.A.H. No. 8 across the Westerly line thereof. Subject to any other easements of record.
