

AMENDMENT TO THE JOINT
RESOLUTION FOR ORDERLY ANNEXATION
BETWEEN THE CITY OF ST. JOSEPH
AND THE TOWN OF ST. JOSEPH

The City of St. Joseph and the Township of St. Joseph hereby jointly agree that the area designated for orderly annexation in the Joint Resolution Between the City of St. Joseph and the Town of St. Joseph designating an area for orderly annexation dated October 2, 1975 be amended to include the following:

Both the City and the Town agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of this resolution, the Municipal Board may review and comment, but shall, within 30 days, order the annexation of the following-described property in accordance with the terms of the joint resolution.

All that part of the Northeast quarter of the Northeast Quarter (NE 1/4) of Section Ten (10), Township one hundred twenty-four (124), Range Twenty Nine (29), Stearns County, Minnesota, lying south of the railroad tracks and East of the West 793.92 feet thereof, containing 1.78 acres, more or less; and the Westerly 100 feet of that part of the west 1/2 of the Northwest 1/4, South of Highway 75 of Section Eleven (11), Township One Hundred Twenty Four (124), Range Twenty Nine (29), containing .33 acres.

WHEREAS, certain territory described below is not presently
included within the incorporated limits of any city; and

WHEREAS, this territory abuts upon the city limits at the
eastern boundary thereof and is urban in character;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JOSEPH;


1. The city council hereby determines (1) that the territory
described below abuts upon the city limits and is or urban in
character; and (2) that none of the territory is now included
within the limits of any city.

2. The council hereby declares its intention to annex the
following territory to the city:


All that part of the Northeast quarter of the Northeast
