WHEREAS, a joint resolution for orderly annexation was adopted by the City of St. Joseph and the the Town of St. Joseph and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of St. Joseph and the Town of St. Joseph indicating their desire that certain property be annexed to the City of St. Joseph pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 1, 1988, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of St. Joseph, Minnesota, the same as if it had originally been made a part thereof:

All that part of the Northeast quarter of the Northeast Quarter (NE1/4) of Section Ten (10), Township one hundred twenty-four (124), Range Twenty Nine (29), Stearns County, Minnesota, lying south of the railroad tracks and East of the West 793.92 feet thereof, containing 1.78 acres, more or less; and the Westerly 100 feet of that part of

the west 1/2 of the Northwest 1/4, South of Highway 75 of Section Eleven (11), Township One Hundred Twenty Four (124), Range Twenty Nine (29), containing .33 acres.

## MORE PARTICULARLY DESCRIBED AS FOLLOWS:

All that part of the Northeast Quarter (NE1/4) of Section Ten (10), Township One Hundred Twenty-Four (124), Range Twenty-Nine (29), Stearns County, Minnesota, lying south of the southerly right-of-way of C.S.A.H. 75 and east of the west 793.92 feet thereof, containing 1.78 acres, more or less; and the westerly 100 feet of that part of the Northwest Quarter (NW1/4) of Section Eleven (11), Township One Hundred Twenty-Four (124), Range Twenty-Nine (29), lying south of the southerly right-of-way of C.S.A.H. 75, containing .33 acre, more or less.
