ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of St. Joseph and the Town of St. Joseph; and

WHEREAS, the resolution indicates their desire that certain property be annexed to the City of St. Joseph pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on November 8, 1993, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of St. Joseph, Minnesota, the same as if it had originally been made a part thereof:

A tract of land lyingin and being a part of the Northwest Quarter of the Southwest Quarter (NW 1/4 SW 1/4) of Section Eleven (11), Township One Hundred Twenty-four (124) North, Range Twenty Nine (29) West, to-wit:

Beginning at a point on the North line of said NW 1/4 SW 1/4

of said Section 11, Township 124 North, Range 29 West, Four Hundred Thirteen and five-tenths (413.50) feet East of the Northwest corner of said NW 1/4 SW 1/4; Thence contiuing due East along said North line of said NW 1/4 SW 1/4 for a distance of ninety-two (92.0) feet; Thence at right angles and due South a distance of One Hundred forty-eight and forty-five hundreths (148.45) feet to an intersection with the Northerly right of way line of old Minnesota trunk highway No. 52; Thence running in a Southwesterly direction along the said Northerly right of way line of said road for a distance of Ninety-two and twenty-five hundreths (92.25) feet to a point which is due South of a point of beginning; Thence due North for a distance of One Hundred fifty-five and threetenths (155.30) feet to the point of beginning and there terminating, said tract containing 32/100 acres (more or less).

That part of the Northwest Quarter of the Southwest Quarter (NW 1/4 SW 1/4) of Section Eleven (11), in Township One Hundred Twenty-four (124) North, of Range Twenty-nine (29) West, in Stearns County, Minnesota, described as follows, towit: Beginning at a point on the North line of said NW 1/4 SW 1/4 of said Section 11, 387.50 feet East of the Northwest corner of said NW 1/4 SW 1/4, thence continuing East along the said North line of said NW 1/4 SW 1/4 a distance of 118 feet, thence at right angles and running South a distance of 148.45 feet to the Northerly right of way line of Old U.S. Highway Number 52, thence running in the Southwesterly direction along the Northerly line of said Old U.S. Highway Number 52, a distance of 118.32 feet, thence running North a distance of 157.11 feet to the point of beginning. Stearns County, Minnesota.
