**AMENDMENT TO THE JOINT
RESOLUTION FOR ORDERLY ANNEXATION
BETWEEN THE TOWNSHIP OF ST. JOSEPH, MINNESOTA
AND THE CITY OF ST. JOSEPH, MINNESOTA**

The Township of St. Joseph and the City of St. Joseph hereby jointly agree that the area designated for orderly annexation in Joint Resolution between the Township of St. Joseph and the City of St. Joseph designating an area for Orderly Annexation dated October 10, 1975 be amended to include the following:

Both the Township and the City agree that no alteration of the stated boundaries of this agreement is appropriate.

Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of this resolution, the Municipal Board may review and comment, but shall, within 30 days, order the annexation of the following-described property in accordance with the terms of the Joint Resolution.

The property is legally described as follows:

All that part of the Northwest Quarter of the Southeast Quarter (NW 1/4 SE 1/4) of Section Ten (10) in Township One Hundred Twenty-four (124) North of Range Twenty-nine (29) West in Stearns County Minnesota, described as follows to-wit: Commencing at a point on the North line of State Trunk Highway Number 3, distant 66 feet Easterly of the West Line of said NW 1/4 of the SE 1/4 and running thence North, parallel, with the Section line, a distance of 198 feet; thence Easterly a distance of 50 feet to a point, 198 feet North of the North Line of State Trunk Highway Number 3; thence South parallel with the Section line, a distance of 198 feet to the North line of State Highway Number 3; thence Westerly along the Northerly line of said State Highway Number 3, a distance of 50 feet to the place of beginning; being the Easterly 50 feet of the Westerly 116 feet of the Southerly 198 feet of that part of the NW 1/4 of the SE 1/4 of Section 10, aforesaid, lying and being Northerly of State Trunk Highway Number 3.

AND ALSO

The North thirty three (33) feet of East Minnesota Street, (formerly State Trunk Highway #3), South of and adjacent to said parcel.

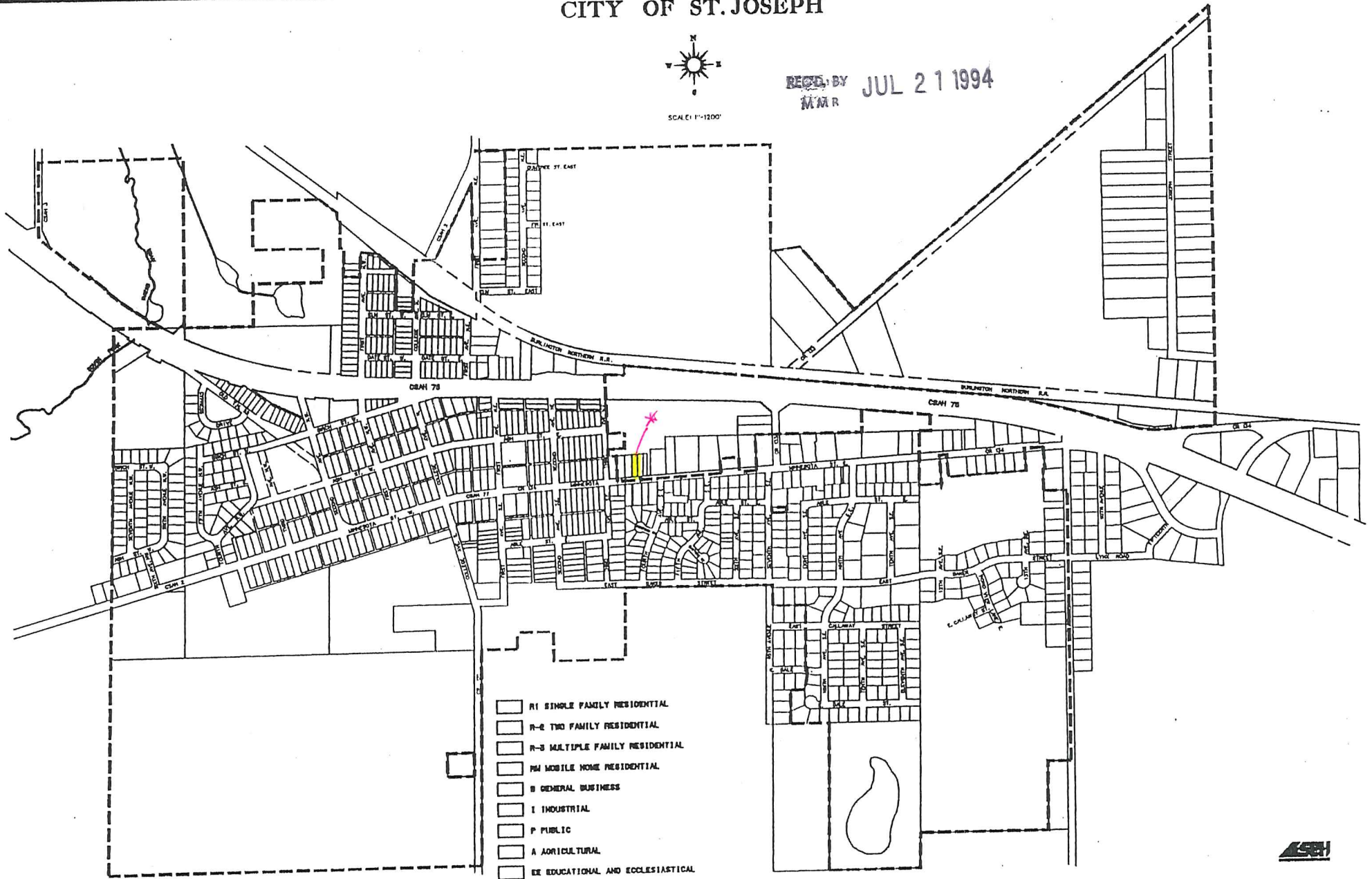
