RESOLUTION FOR ANNEXATION

To: Minnesota Municipal Board

WHEREAS, the City of Watertown and the Town of Watertown, Carver County, Minnesota, did, on April 20, 1976 and May 3, 1976, respectively, enter into a joint resolution designating certain lands in the Town of Watertown as in need of orderly annexation pursuant to Minnesota Statutes 414.032 now Minnesota Statutes 414.0325, and did confer jurisdiction over said land to the Minnesota Municipal Board, and

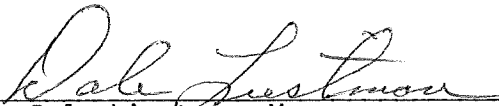
WHEREAS, said joint resolution was for the purpose of providing orderly and planned growth for the benefit of both the City, Town and the County of Carver, and to provide a process to allow the City of Watertown an opportunity in the future to realign the configuration of its corporate limits which at present are uneven and to plan for future development and growth, and

WHEREAS, there now exists certain lands within said orderly annexation area which are now urban or suburban in character for which the City of Watertown is capable of providing all municipal services and which it would be in the best interest of both said lands and the City of Watertown if said lands were annexed to the City of Watertown.

NOW, THEREFORE, Be it resolved by the City of Watertown:

That those certain lands as described on Exhibit "A" and as shown on Exhibit "B", attached hereto and made a part hereof are lands that should now be annexed to the City of Watertown pursuant to the orderly annexation agreement between the City of Watertown and Town of Watertown, and the Minnesota Municipal Board is hereby requested to act on this resolution for annexation pursuant to Minnesota Statutes 414.0325.

EXHIBIT "A"

Lands to be Annexed

(Carver County, Minnesota)

PARCEL A (Joseph P. and Dorothy Pysick)

Outlots 72 and 73, excepting therefrom the Northeasterly 105.3 feet of Outlot 72 and the Southwesterly 36.1 feet of Outlot 73, Town of Watertown, according to the recorded plat thereof. ALSO, the Northeasterly 33 feet of White Street adjoining and abutting said Outlot 72.

PARCEL B (Walter Albert Neumann, Jr. and Kay Dorothy Neumann)

That part of Outlots 72 and 73, Town of Watertown, according to the recorded plat thereof, described as follows: The Northeasterly 105.3 feet of Outlot 72 and the Southwesterly 36.1 feet of Outlot 73.

PARCEL C (Robert J. and June E. Borrell)

Commencing at a point on the Northerly line of Outlot 54 which is 200 feet Northwesterly of the Northeast corner thereof; thence Northwesterly along said Northerly line a distance of 200 feet to the Northwest corner of said Outlot 54; thence Southwesterly along the Westerly line of said Outlot 54 a distance of 150 feet to a point; thence Southeasterly parallel to the Northerly line of said Outlot 54 a distance of 200 feet to a point; thence Northeasterly parallel to the Easterly line of said Outlot 54 a distance of 150 feet to the point of beginning, Town of Watertown, according to the recorded plat thereof.
