WHEREAS, a joint resolution for orderly annexation was adopted by the City of

Watertown and the Town of Watertown; and

WHEREAS, an amendment to the joint resolution was received from the City of

Watertown and the Town of Watertown requesting that certain property be annexed to the City of

Watertown pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic

and Long Range Planning may review and comment, but shall within 30 days order the

annexation pursuant to said subdivisions; and

WHEREAS, Reorganization Order No. 192, effective March 8, 2005, has transferred the

duties of the Director to the Chief Administrative Law Judge.

WHEREAS, on May 11, 2006, the Chief Administrative Law Judge reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Watertown, Minnesota, the same

as if it had originally been made a part thereof:

That part of the plat of Village of Watertown, Carver County, Minnesota, described as follows: All of Outlots 79 and 80; Also that part of Outlots 92 and 93 lying South and East of Mapes Creek; Also the North 103.0 feet of that part of Outlot 90 lying South and East of Mapes Creek; Also the North 103.0 feet of Outlots 81 and 91; Also that part of the North 103.0 feet of Outlot 73 lying West of the East 116.0 feet thereof; Also that part of Outlot 74 lying West of the East 116.0 feet thereof; Also that part of Outlot 74 lying West of the East 116.0 feet thereof; Also that part of Mapes Creek, and North of a line drawn parallel with and 103.0 feet southwesterly of the Southwest line of Outlots 80 and 92. Also, all that part of the South Half of State Highway No. 25 lying northerly of and adjacent to said property not included therein.

EXCEPT that part of Outlot 74, Village of Watertown, according to the recorded plat thereof, Carver County, Minnesota, described as follows:
