EXHIBIT A ANNEXATION Description

Commencing at the Southwest corner of Section 33, Township 107 North, Range 14 West, Olmsted County, Minnesota, and running thence due east along the south line of said section a distance of 1208.55 feet to a point in the center of the pavement of Trunk Highway No. 14; thence deflecting to the left on a 2 degrees 30 minutes curve, radius 2291.83 feet for a distance of 373.1 feet; thence tangent to said curve North 56 degrees 52 minutes 20 seconds east along the center of said trunk highway pavement a distance of 480.4 feet to a point intersecting the road to the Rochester Golf and Country Club; thence south 34 degrees 40 minutes west along said Rochester Golf and Country Club road a distance of 533.0 feet to the south line of said Section 33; thence due west a distance of 427.8 feet to the place of beginning.
