EXHIBIT A

That part of the West Half of the Southeast Quarter of Section 34, Township 107 North, Range 14 West, Olmsted County, Minnesota, described as follows:

Beginning at the intersection of the southerly line of First Street N.W. and the easterly right-of-way line of T.H. 52; thence northerly on a Minnesota State Plane Grid Azimuth from north of 358 degrees 42 minutes 38 seconds along said easterly right-of-way line of T.H. 52, also being the westerly line of Rochester Shopping Center Addition, according to the plat thereof on file at the County Recorder's Office, Olmsted County, Minnesota, 2027.62 feet to the intersection with the northerly right-of-way line of Fourth Street N.W.; thence westerly 268 degrees 42 minutes 38 seconds azimuth 200.00 feet to the westerly right-of-way line of T.H. 52; thence southerly 178 degrees 42 minutes 38 seconds azimuth along said westerly right-of-way line 2027.62 feet; thence easterly 88 degrees 42 minutes 38 seconds azimuth 200.00 feet to the point of beginning.

Said tract contains 9.31 acres more or less.
