

JOINT RESOLUTION FOR ANNEXATION OF AREA
DESIGNATED FOR ORDERLY ANNEXATION

CITY OF GAYLORD - DRYDEN TOWNSHIP

WHEREAS, the City of Gaylord on May 4, 1977, entered into an Orderly Annexation Agreement with Dryden and Sibley Townships which conferred on the Minnesota Municipal Board jurisdiction over annexations in the Orderly Annexation Area, and

WHEREAS, certain territory, located in Dryden Township, described below, is about to become urban in character and in need of water and other municipal services in the immediate future, and

WHEREAS, this joint petition is made pursuant to M.S.A. 414.0325, Subdivision 1 requesting annexation within 30 days without a hearing, and

WHEREAS, said area is in need of orderly annexation and no alteration of its stated boundaries is appropriate, and

WHEREAS, said area is in need of orderly annexation and no consideration by the Minnesota Municipal Board is necessary.

BE IT RESOLVED BY THE CITY COUNCIL OF GAYLORD, MINNESOTA AND THE BOARD OF DRYDEN TOWNSHIP, SIBLEY COUNTY, MINNESOTA, that annexation proceedings are hereby initiated and that this joint resolution shall be submitted to the Minnesota Municipal Board, which shall, by Minnesota Statute 414.0325, Subdivision 1, order the annexation, within 30 days according to the terms of this resolution, of the parcel described in the attached "Exhibit A".

Any increase in mill levy for the area shall be done in substantially equal proportions over a period of three years. This shall be done according to the terms of Paragraph 3 of the Orderly Annexation Agreement.
