WHEREAS, a joint resolution for orderly annexation was adopted by the City of Oronoco and the Town of Oronoco; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Oronoco pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, Reorganization Order No. 192, effective March 8, 2005, has transferred the duties of the Director to the Chief Administrative Law Judge; and

WHEREAS, on June 19, 2006, the Chief Administrative Law Judge has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Oronoco, Minnesota, the same as

if it had originally been made a part thereof:

That part of the South Half of the Southeast Quarter of Section 17, Township 108 North, Range 14 West, Olmsted County, Minnesota, described as follows:

Commencing at the southwest corner of the Southeast Ouarter of said Section 17: Thence South 89 degrees 03 minutes 01 second East, assumed bearing, along the South line thereof, 2486.52 feet; thence North 59 degrees 11 minutes 02 seconds West, 370.13 feet for the point of beginning; thence continue North 59 degrees 11 Minutes 02 seconds West, 446.01 feet; thence South 85 degrees 10 minutes 27 seconds West, 483.83 feet; thence northerly 394.85 feet along nontangential curve concave westerly, central angle of 88 degrees 01 minute 38 seconds, radius of 257.00 feet, and the chord of said curve bears North 19 degrees 58 minutes 21 seconds West, 357.14 feet; thence North 28 degrees 14 minutes 38 seconds East, 336.00 feet; Thence North 20 degrees 54 minutes 31 seconds East, 292,44 feet; thence North 89 Degrees 09 minutes 10 seconds West, 602.75 feet; thence South 42 degrees 42 Minutes 51 seconds West, 289.02 feet; thence South 60 degrees 41 minutes 27 Seconds West, 243.16 feet; thence North 29 degrees 18 minutes 33 seconds West, 120.00 feet; thence North 60 degrees 41 minutes 27 seconds East, 224.18 feet: Thence North 42 degrees 42 minutes 51 second East, 216.21 feet to the north line of The South Half of said Southeast Quarter; thence South 89 degrees 09 minutes 10 seconds East along said north line, 1927.37 feet to the northeast corner of said South Half; thence South 56 degrees 41 minutes 15 seconds West, 455.72 feet; thence South 06 degrees 16 minutes 57 seconds West, 869.83 feet to the point of beginning.
