WHEREAS, a joint resolution for orderly annexation was adopted by the City of New York Mills and the Town of Newton; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of

ORDER

New York Mills pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic

and Long Range Planning may review and comment, but shall within 30 days order the

annexation of land pursuant to said subdivisions; and

WHEREAS, Reorganization Order No. 192, effective March 8, 2005, has transferred the

duties of the Director to the Chief Administrative Law Judge; and

WHEREAS, on December 20, 2007, the Chief Administrative Law Judge has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of New York Mills, Minnesota, the

same as if it had originally been made a part thereof:

That part of the W ½ of the SW ¼ of Section 9, Township 135, Range 37, described as follows: To find the point of beginning of the tract to be described, commence at the Southwest corner of said W $\frac{1}{2}$ of SW $\frac{1}{4}$; thence North 1 degree 11 minutes 18 seconds East on and along the West line of said Section 9 a distance of 1,218.00 feet to the point of beginning of the tract to be described; thence South 1 degree 11 minutes 18 seconds West on and along said West line, a distance of 190 feet; thence Easterly at right angles to said West line a distance of 447 feet; thence North 1 degree 11 minutes 18 seconds East, on and along a line that is parallel with said West line, a distance of 490 feet; thence North 88 degrees 48 minutes 42 seconds West a distance of 84.08 feet, more or less, to the point of intersection with a line that is parallel with, and 363 feet distant from, the said West line of said Section 9 when measured at right angles to said West line; thence South 1 degree 11 minutes 18 seconds West along said last mentioned parallel line, to the point of intersection with a line bearing South 89 degrees 59 minutes 41 seconds East from the point of beginning (said line also being parallel with the South line of said Section 9); thence North 89 degrees 59 minutes 41 seconds West to the point of beginning. This description assumes that the South line of said W ½ of SW ¼ bears North 89 degrees 59 minutes 41 seconds West.

IT IS FURTHER ORDERED: That pursuant to Minn. Stat. 414.036, the Town of

Newton will be reimbursed by the City of New York Mills in accordance with the terms of Joint

Resolution No. 11-13-07 signed by the City on November 13, 2007 and the Town of October 8,

2007.
