JOINT RESOLUTION ON ORDERLY ANNEXATION

WHEREAS, by Agreement Between the City of New Ulm, Brown County, Minnesota, and Milford Township, Brown County, Minnesota, To Establish Orderly Annexation dated May 6, 1980, the City of New Ulm and Township of Milford provided for the Orderly Annexation of an eight-acre, more or less, parcel of Milford Township to be annexed to the City of New Ulm;

WHEREAS, such Agreement provided that upon preparation and presentation to the City of New Ulm and Township of Milford of a proposed plat for such property, the City of New Ulm could petition the Minnesota Municipal Board for annexation of such property;

WHEREAS, the owner of such property has now presented to the parties hereto a preliminary plat for such property and it is appropriate that Orderly Annexation of such property be implemented; and

WHEREAS, this matter is pending before the Minnesota Municipal Board as MMB Docket No. A3449;

NOW, THEREFORE, be it jointly resolved by the City Council of the City of New Ulm and the Township Board of the Township of Milford, both in Brown County, Minnesota, as follows:

- l. That the property subject to this resolution and the owner thereof are as follows:
 - A. Property description: Beginning at the Northeast corner of Lot "B" of the East Half of the West Half, Section Thirty (30), Township One Hundred Ten (110) North, Range Thirty (30) West, Brown County, Minnesota, which is 1,581.55 feet North OO Degrees, 4 Minutes West of the Center of said Section 30, this being the point of beginning; then North OO Degrees, 4 Minutes West along the half section line, a distance of 1,047.55 feet; thence South 89 Degrees, 56 Minutes West a distance of 343.46 feet; thence South OO Degrees 4 Minutes East a distance of 1,047.55 feet; thence North 89 Degrees, 56 Minutes East a distance of 343.46 feet to the point of beginning, containing eight acres, more or less.
 - B. Property owner: Sunset Heights, a partnership.
- 2. That the terms and conditions of the Agreement Between the City of New Ulm, Brown County, Minnesota, and Milford Township, Brown County, Minnesota, To Establish Orderly Annexation dated May 6, 1980, have been fulfilled and that the owners of the described property have prepared and presented a proposed plat for such property.

- 6. The City of New Ulm and Township of Milford hereby request that the Minnesota Municipal Board issue its order for the annexation of such property in accordance with this resolution forthwith.
