AGREEMENT BETWEEN THE CITY OF MARSHALL)
AND THE TOWN OF LAKE MARSHALL PURSUANT TO)
MINNESOTA STATUTES 414)

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Marshall and the Town of Lake Marshall; and

WHEREAS, an amendment to the joint resolution was received from the City of Marshall and the Town of Lake Marshall requesting that certain property be annexed to the City of Marshall pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on April 16, 1993, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Marshall, Minnesota, the same as if it had originally been made a part thereof:

All that part of the Northwest Quarter of the Southwest Quarter of Section 2, Township 111 North, Range 41 West, Lyon County, Minnesota, described as follows:

Commencing at the Northwest corner of said Southwest Quarter, thence 00 degrees 41 minutes 24 seconds East, assumed bearing, along the West line of said Southwest Quarter 636.19 feet; thence South 89 degrees 33 minutes 48 seconds East, parallel with the south right of way line of Minnesota Trunk Highway No. 19, 72.40 feet to a point on the Easterly right of way line of

Minnesota Trunk Highway Number 23; thence continuing South 89 degrees 33 minutes 48 seconds East, parallel with said South right of way line 327.60 feet; thence South 00 degrees 41 minutes 24 seconds East, parallel with said West line of the Southwest Quarter 200.00 feet; thence North 89 degrees 33 minutes 48 seconds West parallel with said South right of way line 348.47 feet, to a point on said Easterly right of way line of Minnesota Trunk Highway Number 23; thence Northeasterly along said Easterly right of way line, along a curve not tangent to the last described line, to the left having a central angle of 04 degrees 48 minutes 31 seconds, a radius of 2391.83 feet, and an arc length of 200.74 feet to the point of beginning.


Said tract of land contains 1.55 acres more or less and is subject to any existing easements.
