WHEREAS, a joint resolution for orderly annexation was adopted by the City of Marshall and the Town of Fairview; and

WHEREAS, an amendment to the joint resolution was received from the City of Marshall and the Town of Fairview requesting that certain property be annexed to the City of Marshall pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on November 3, 1995, the Minnesota Municipal Board has reviewed and accepted the amendment to the joint resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Marshall, Minnesota, the same as if it had originally been made a part thereof:

All that part of the Northeast Quarter of Section 28, Township 112 North, Range 41 West lying southeasterly of the southeasterly right-of-way of the Burlington Northern Railway Company, and westerly of the east line of Fairview Township Road No. T-306 established by resolution recorded on January 19, 1988 in Book 63 of Misc., page 191 as Doc. No. 68931, subject to road right-of-way, said area containing 10.33 acres more or less.

IT IS FURTHER ORDERED: That the effective date of this order is November 3, 1995.
