RESOLUTION

WHEREAS, John and Sybil DeKrey have petitioned for annexation of their 2.08 acre parcel of property to allow for connection to the City water and sanitary sewer systems under a Joint Resolution Between the Town of Oakport and City of Moorhead Designating an Area for Orderly Annexation Pursuant to Minnesota Statute 414.0325 dated August 1, 1983; and

WHEREAS, the City Council of the City of Moorhead will hold three readings of an ordinance for annexation pursuant to Paragraph 5 of the Joint Resolution Between the Town of Oakport and City of Moorhead; and

WHEREAS, said proposed annexation is in all respects and accordances consistent with the aforementioned ordinance;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Moorhead that the City does hereby pursuant to Minnesota Statute 414.0325 extend the corporate limits of the City to include the following described land, and the same is hereby annexed to and included within the City as effectively as if it had originally been a part thereof, said land being described as follows:

John and Sybil DeKrey Property: Parcel 17. Part of the Northeast Quarter of the Northwest Quarter (Lot 2), Section Thirty-two (32), Township One Hundred Forty (140), Range Forty-eight (48), described as follows: Commencing at a point on the Section line between Section 29 and 32, 1889.80 feet West of the Northeast corner of the Northwest Quarter of the Northeast Quarter of Section Thirty-two (32), Township One Hundred Forty (140), Range Forty-eight (48), thence South $0^{\circ}34'$ East 299.2 feet, thence East 298.1 feet, thence North $2^{\circ}43'$ East 233.4 feet, thence North $32^{\circ}43'$ East 74.0 feet to said section line; thence South $89^{\circ}47'$ West on said section line 352.1 feet to point of beginning. Containing 2.08 acres, more or less.

BE IT FURTHER RESOLVED by the City Council of the City of Moorhead that the aforementioned property owners will be allowed to connect to the sanitary sewer and water systems of the City of Moorhead before final action on the annexation is taken by the Minnesota Municipal Board.
