JOINT RESOLUTION BETWEEN THE TOWNSHIP OF
PEMBINA AND THE CITY OF MAHNOMEN
DESIGNATING AN AREA FOR ORDERLY ANNEXATION

The Township of Pembina and the City of Mahnomen hereby jointly agree to the following:

1. That the following described area in Pembina Township is subject to orderly annexation pursuant to Minnesota Statutes 414.032, and the parties hereto designate this area for orderly annexation:

The unplatted portion of Government Lot Four (4), Section Two (2), Township One Hundred Forty Four (144) North, Range Forty Two (42) West of the 5th P.M. in Minnesota, subject to the easements of existing highways over and across said premises, And Less the following described tract; A tract of land in Government Lot Four (4), Section Two (2), Township One Hundred Forty Four (144) North, Range Forty Two (42) West, described as follows; Commencing on the East boundary line of Government Lot Four (4), at the point of intersection of the South right of way line of Minnesota State Highway No. 200 therebeing, thence in a Westerly direction along and upon said South right of way line a distance of 350 feet, thence due South a distance of 375 feet, thence East 350 feet, more or less to the East boundary line of said Government Lot Four (4), Section 2-144-42, thence North along and upon the East boundary line a distance of 375 feet, more or less to the point of beginning

- 2. That the City shall follow City policies concerning the extension of Municipal utilities.
- 4. In the annexation within the orderly annexation area the parties agree to the following division of financial obligations:

The Township of Pembina shall received 80% of the real estate taxes received in the annexed area during the first two years after the adoption of the Agreement; 60% in the third and fourth year; 40% in the fifth and sixth year.

AMENDMENT TO THE JOINT

RESOLUTION BETWEEN THE TOWN
