


AMENDMENT TO THE JOINT  
RESOLUTION BETWEEN THE TOWN  
OF MARSHAN AND THE CITY OF HASTINGS  
DESIGNATING AN AREA FOR ORDERLY ANNEXATION

The Township of Marshan and the City of Hastings hereby jointly agree that the area designated for orderly annexation in the Joint Resolution Between the Town of Marshan and the City of Hastings designating an Area for Orderly Annexation approved on May 3, 1986 be amended to include the following:


Both the Town and the City agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of the initiating resolutions passed and adopted by both Marshan Township and the City of Hastings, the Municipal Board may review and comment, but shall, within 30 days, order the annexation in accordance with the terms of the joint resolution.

## JOINT ANNEXATION RESOLUTION

WHEREAS, the City of Hastings and Marshan Township has an Orderly Annexation Agreement approved in May of 1984; and

WHEREAS, the real property owners of Lot 7, Block 2 of Siebens 1st Addition, 16180 LeRoy Avenue, Hastings, Minnesota, located in Marshan Township, Dakota County, Minnesota, have petitioned the City of Hastings for annexation of such property into the City of Hastings with removal from the jurisdiction of Marshan Township as a result of poor quality of water and the fact that the home shares a well with three other homes; and

WHEREAS, the Township of Marshan and the City of Hastings both believe that the property proposed to be annexed, above described, is in need of orderly annexation, and that no alteration of the above stated boundaries is necessary; and

WHEREAS, Marshan Township Board and the City Council of the City of Hastings believe that no consideration by the Minnesota Municipal Board is necessary to set annexation and both agree that the above described area should be annexed, and become part of the City of Hastings, subject to all of the Ordinances, controlls, and other obligations and benefits of property located within the City of Hastings, and should cease to be a part of Marshan Township and be released from the jurisdiction thereof;

NOW, THEREFORE, the City Council of the City of Hastings and the Township Board of Supervisors of the Township of Marshan do hereby resolve as follows:

1. The above described property proposed to be annexed is in need of orderly annexation and no alteration of its stated boundaries as set forth is appropriate.

2. The conditions of annexation should be that said property which cease to become part of the Township of Marshan and would be annexed and include within the Corporate Limits of the City of Hastings and would in all things become subject to the jurisdiction of the City of Hastings and become a part thereof and would be released from this jurisdiction of the Township of Marshan and would no longer be a part thereof.

3. That a Joint Resolution set forth herein shall be submitted by the City Clerk of the City of Hastings to the Minnesota Municipal Board for said Board to proceed and order the annexation of the above described property pursuant to the terms of Minnesota Statutes, Section 414.0325.

4. That the Township Officers of the Township of Marshan and the Mayor and the City Clerk of the City of Hastings are hereby authorized and directed to take such action and execute such documents as may be necessary to accomplish the above set forth annexation.

The above resolution is hereby adopted and approved by the Town Board of Supervisors of the Marshan Township, Dakota County, Minnesota, on this 19 day of aug, 1986.


