

JOINT ANNEXATION RESOLUTION

WHEREAS, the City of Hastings and Marshan Township have an Orderly Annexation Agreement adopted in May of 1984; and

WHEREAS, the majority of the real property owners, of the following described property; Lots 2 thru 14 Bernard Acres; also a strip of land 200' in depth lying adjacent to and immediately west of the westerly right of way of Trunk Highway 316 bounded on the north by the westerly extension of the center line of 31st Street (160th St.) and bounded on the south by a line parallel with the centerline of 31st St. and 1270 feet southerly thereof. Also included is the right of way of Trunk Highway 316 between the centerline of 31st St. and a line 1270 feet southerly thereof. All of the above property lies in the NE 1/4 of the Northwest One Quarter of Section 3 T114N, R17W, located in Marshan Township, Dakota County, Minnesota, have petitioned the City of Hastings for annexation of such property into the City of Hastings with removal from the jurisdiction of Marshan Township as a result of poor quality of water and the need for a municipal sewer system; and

WHEREAS, the Township of Marshan and the City of Hastings both believe that the property proposed to be annexed, above described, is in need of orderly annexation, and that no alteration of the above stated boundaries is necessary; and

WHEREAS, the Marshan Township Board and the City Council of the City of Hastings believe that no consideration by the Minnesota Municipal Board is necessary to said annexation and both agree that the above described area should be annexed, and become a part of the City of Hastings, subject to all of the Ordinances, controls, and other obligations and benefits of the property located within the City of Hastings, and should cease to be a part of Marshan Township and be released from the jurisdiction thereof;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Hastings and the Township Board of Supervisors of the Township of Marshan, the following:

1. The above described property proposed to be annexed is in need of orderly annexation and no alteration of its stated boundaries as set forth is appropriate.

2. That the conditions of annexation should be that said property which ceased to become a part of the Township of Marshan and would be annexed and include within the corporate limits of the City of Hastings and would in all things become subject to the jurisdiction of the City of Hastings and become a part thereof and would be released from this jurisdiction of the Township of Marshan and would no longer be a part thereof.

3. That a Joint Resolution set forth herein shall be submitted by the City Clerk of the City of Hastings to the Minnesota Municipal Board for said Board to proceed and order the annexation of the above described property pursuant to the terms of Minnesota Statutes, Section 414.0325.

4. That the Township Officers of the Township of Marshan and the Mayor and the City Clerk of the City of Hastings are hereby authorized and directed to take such action and execute such documents as may be necessary to accomplish the above set forth annexation.


