RESOLUTION NO. 57-87 JOINT ANNEXATION RESOLUTION

WHEREAS, the City of Hastings and Marshan Township has an Orderly Annexation Agreement approved in May of 1984; and

WHEREAS, the real property owners of Lot 7 and 8, Sunset View Addition, 16014 and 16060 Levi Avenue, Hastings, Minnesota, located in Marshan Township, Dakota County, Minnesota, have requested the City of Hastings for annexation of said property into the City of Hastings with removal from the jurisdiction of Marshan Township as a result of high nitrate levels (over 20 ppm) in their water and poor septic systems; and

WHEREAS, the City of Hastings has previously run water and sewer lines to the property lines of these two (2) parcels in conjunction with a

previous project; and

WHEREAS, the Township of Marshan and the City of Hastings both believe that the property proposed to be annexed, above described, is in need of orderly annexation, and that no alteration of the above stated

boundaries is necessary; and

WHEREAS, Marshan Township Board and the City Council of the City of Hastings believe that no consideration by the Minnesota Municipal Board is necessary to set annexation and both agree that the above described area should be annexed, and become part of the City of Hastings, subject to all of the Ordinances, controls, and other obligations and benefits of property located within the City of Hastings, and should cease to be a part of Marshan Township and be released from the jurisdiction thereof;

NOW, THEREFORE, the City Council of the City of Hastings and the Township Board of Supervisors of the Township of Marshan do hereby resolve

as follows:

1. The above described property proposed to be annexed is in need of orderly annexation and no alteration of its stated boundaries as set forth

is appropriate.

2. The conditions of annexation should be that said property which cease to become part of the Township of Marshan and would be annexed and include within the Corporate Limits of the City of Hastings and would in all things become subject to the jurisdiction of the City of Hastings and become a part thereof and would be released from this jurisdiction of the Township of Marshan and would no longer be a part thereof.

3. That a Joint Resolution set forth herein shall be submitted by the City Clerk of the City of Hastings to the Minnesota Municipal Board for said Board to proceed and order the annexation of the above described property pursuant to the terms of Minnesota Statutes, Section 414.0325.

4. That the Township Officers of the Township of Marshan and the Mayor and the City Clerk of the City of Hastings are hereby authorized and directed to take such action and execute such documents as may be necessary to accomplish the above set forth annexation.
