AND THE TOWN OF AUSTIN PURSUANT TO)	
MINNESOTA STATUTES 414)	

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Austin and the Town of Austin and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Austin indicating their desire that certain property be annexed to the City of Austin pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on December 10, 1991, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Austin, Minnesota, the same as if it had originally been made a part thereof:

N. 262.00 feet of Lot 1, Block 6, Austin Homesteads 2.50 Acres;

Also including the following:

Beginning at the northeast corner of Lot 1, Block 6, Austin Homesteads, Mower County, Minnesota, this point also being on the south property line of 10th

Avenue S.W. thence easterly 33 feet on said south property line thence northerly at a right angle to the north property line of 10th Avenue S.W. thence north-westerly on said north right-of-way line to the northwest corner of Lot 6, Block 4, Oak Ridge Addition, thence westerly on a straight line to the northeast corner of Lot 8, Block 3, Oak Ridge Addition, this point also being on 10th Avenue S.W. right-of-way line thence southeasterly along said right-of-way line to the point of beginning.




