

AMENDMENT TO THE JOINT  
RESOLUTION FOR ORDERLY ANNEXATION  
BETWEEN THE TOWNSHIP OF SHELBY  
AND THE CITY OF AMBOY

The Township of Shelby and the City of Amboy hereby jointly agree that the area designated for orderly annexation in the Joint Resolution Between the Township of Shelby and the City of Amboy Designating an Area for Orderly Annexation dated May 5, 1986, be amended to include the following:

Both the Township and the City agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of this resolution, the Municipal Board may review and comment, but shall, within 30 days, order the annexation of the following-described property in accordance with the terms of the joint resolution.

The East 345 feet of the West 523 feet of the North 193 feet of the South one-half of the Northwest quarter, Section 23-105-28 (1.53 acres), and

A tract of land in the Southwest Quarter of the Northwest Quarter of Section 23, Township 105 North, Range 28 West in Blue Earth County, Minnesota, described as follows:

Commencing at the southwest corner of the Northwest Quarter of the Southwest Quarter of Section 23, Township 105 North, Range 28 West in Blue Earth County, Minnesota; thence North along the West line of Section 23 a distance of 2444.70 feet to the point of beginning; thence East parallel with the South line of the Northwest Quarter of the Southwest Quarter a distance of 523 feet, more or less, to the west line of Stevens Subdivision in the Village (now City) of Amboy, according to the plat on file and of record in the office of the Blue Earth County Recorder; thence North along the west line of Stevens Subdivision a distance of 13.84 feet to a line lying parallel with and 193.00 feet South of the North line of the Southwest Quarter of the Northwest Quarter of Section 23; thence West parallel with the North line of the Southwest Quarter of the Northwest Quarter a distance of 523 feet, more or less, to the West line of Section 23; thence South along the west line of Section 23 a distance of 14.30 feet to the point of beginning.



