
WHEREAS, the owner(s) of the property described in Attachment A have petitioned the City of North Mankato for annexation; and

WHEREAS, said property lies within the orderly annexation area as described in Resolution No. 79-86; and


WHEREAS, the Petition for Annexation of said property complies with the terms of the Orderly Annexation Agreement,

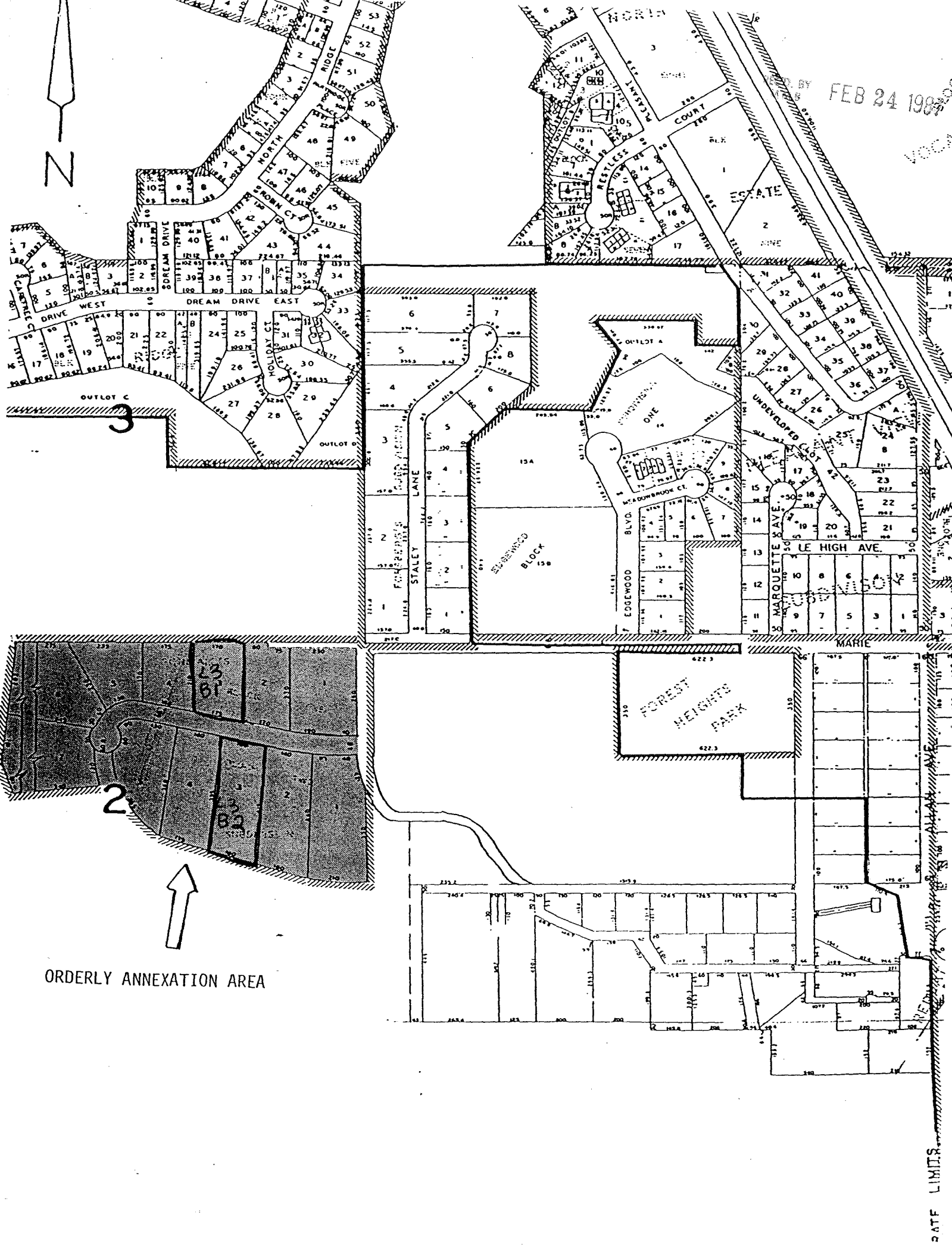

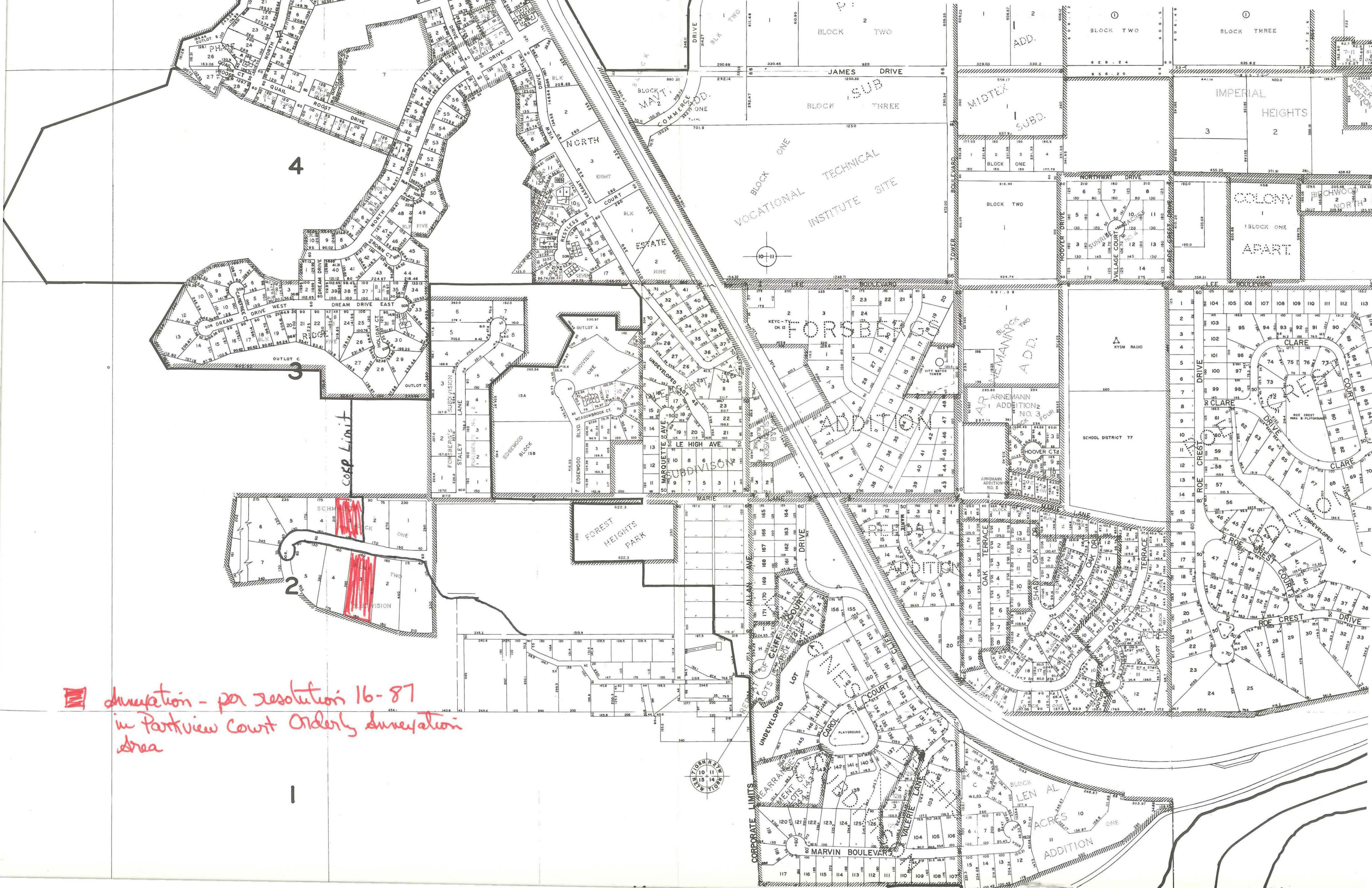
