



CONSIDERATION OF PURCHASE OF VIEAU HOUSE. Upon motion by Siegmann, seconded by Peterson, City Council directed the Housing and Redevelopment Authority to look at the purchase of the Vieau home, all members voting in favor.

SEWER CLEANING MACHINE SPECIFICATIONS. 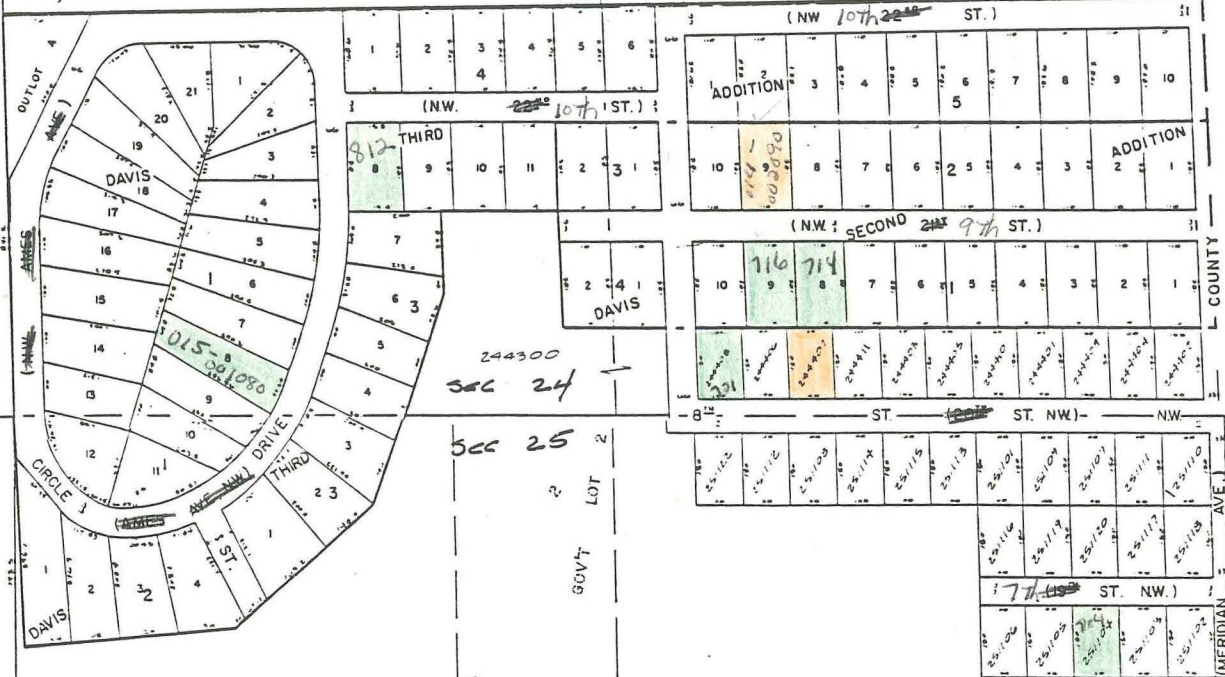
