AGREEMENT BETWEEN THE CITY OF SAUK RAPIDS) ORDER
AND THE TOWN OF SAUK RAPIDS PURSUANT TO)
MINNESOTA STATUTES 414)

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Sauk Rapids and the Town of Sauk Rapids and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Sauk Rapids indicating their desire that certain property be annexed to the City of Sauk Rapids pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on August 5, 1992, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Sauk Rapids, Minnesota, the same as if it had originally been made a part thereof:

9th Avenue North: The west 40.00 feet of the Southeast Quarter of Section 14, Township 36 North, Range 31, Benton County, Minnesota lying south of the easterly extension of the north line of Prairie Garden Plat Two, City of Sauk Rapids,

a duly recorded plat on file and of record in the Office of the County Recorder, Benton County, Minnesota, and north of the westerly extension of the northerly line of Lot 1, Block 1, Whitney Oaks Plat Three, City of Sauk Rapids, a duly recorded plat on file and of record in the Office of the County Recorder, Benton County, Minnesota.


and,

5th Street South: That part of 5th Street South right of way that lies westerly of the westerly right of way line of U.S. Highway No. 10, southerly of the centerline of 5th Street South (County Road 46) and which lies easterly of the east 150.00 feet of the Southwest Quarter of the Northwest Quarter (SW1/4, NW1/4), Section 25, Township 36 North, Range 31 West, Benton County, Minnesota. Said annexation is also a part of the Southeast Quarter of the Northwest Quarter (SE1/4, NW1/4) of said Section 25.

IT IS FURTHER ORDERED: That the effective date of this order is August 5, 1992.
