

RESOLUTION NO. 88-22

A RESOLUTION ANNEXING HIGHWAY RIGHTS OF WAY

WHEREAS, the City of Sauk Rapids and the Town of Sauk Rapids have agreed to the orderly annexation of lands adjacent to the City of Sauk Rapids, and

WHEREAS, the annexation of certain U.S. Hwy 10 and Benton CSAH 3 rights-of-way will clarify jurisdictional boundaries and ensure contiguous boundaries.


NOW THEREFORE BE IT RESOLVED BY THE CITY OF SAUK RAPIDS:

That the following described highway rights-of-way are hereby annexed:

- A. US Hwy 10 Right-of-Way in Section 24, T36N, R31W southerly of Benton County CSAH 3.
- B. US Hwy 10 Right-of-Way in Section 25, T36N, R31W northerly of the St. Cloud city limits.
- C. Benton County CSAH 3 Right-of-Way westerly of the intersection of Sauk Rapids Town Road No. 2 to the Sauk Rapids city limits.


Be It Further Resolved, this Resolution and the appropriate filing fee shall be mailed to the Minnesota Municipal Board for its approval.





A RESOLUTION AMENDING THE CORPORATE LIMITS OF THE CITY

WHEREAS, Resolution No. 87-38 and Ordinance No. 218 annexed parts of the Southwest Quarter of the Northwest Quarter (SW1/4 NW1/4) of Section 25, Township 36 North, Range 31 West, and

WHEREAS, it has been determined that all the land lying in the areas intended to be annexed were not, and

WHEREAS, the city wishes to annex this land.

NOW THEREFORE BE IT RESOLVED BY THE SAUK RAPIDS CITY COUNCIL THAT:


1. That the land lying in all that part of the Southwest Quarter of the Northwest Quarter (SW1/4 NW1/4) Section 25, lying southerly of the center line of County Road No. 46 except therefrom the east 150^{feet} thereof not previously annexed is hereby annexed.
2. That the quantity of land described above is approximately .86 acres and shown on the attached Map Exhibit A.
3. In accord with MS414.0325 the Minnesota Municipal Board is asked to order the annexation.


