desire that certain property be annexed to the City of Sauk Rapids pursuant to M.S.

414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325, M.S. 414.11, and M.S. 414.12 states that in certain

circumstances the Director of the Office of Strategic and Long Range Planning may review

and comment, but shall within 30 days order the annexation of land pursuant to said

subdivisions; and

WHEREAS, on January 18, 2000, the Director of the Office of Strategic and Long

Range Planning has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed

to the City of Sauk Rapids, Minnesota, the same as if it had originally been made a part

thereof:

The following described property is hereby annexed: That part of the East Half of the Southeast Quarter of Section 15, Township 36 North, Range 31 West, Benton County, Minnesota, described as follows: Commencing at the southeast corner of said Section 15; thence north on an assumed bearing along the east line of said Section 15, a distance of 1,064.86 feet for the point of beginning of the tract to be described; thence continue north along said east line 1,016.00 feet; thence west at right angles 233.29 feet; thence southwesterly 179.45 feet along a tangential curve concave to the southeast having a radius of 165.34 feet and a central angle of 62 degrees 11 minutes 20 seconds; thence South 27 degrees 48 minutes 40 seconds West, tangent to said curve 450.00 feet; thence South 62 degrees 11 minutes 20 seconds East, 200.00 feet; thence southeasterly 161.97 feet along a tangential curve concave to the southeasterly 161.97 feet along a tangential curve concave to the southeasterly 161.97 feet along a tangential curve concave to the south tangent to said curve and parallel with the east line of said Section 15, a distance of 300.00 feet; thence South 89 degrees 13 minutes 45 seconds East 333.00 feet to the point of beginning, less that part previously annexed to the city.
