ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Sauk

Rapids and the Town of Sauk Rapids; and

WHEREAS, a resolution was received from the City of Sauk Rapids indicating their

desire that certain property be annexed to the City of Sauk Rapids pursuant to M.S. 414.0325,

Subd. 1; and

WHEREAS, M.S. 414.0325, M.S. 414.11, and M.S. 414.12 states that in certain

circumstances the Director of the Office of Strategic and Long Range Planning may review and

comment, but shall within 30 days order the annexation of land pursuant to said subdivisions;

and

WHEREAS, on May 12, 2000, the Director of the Office of Strategic and Long Range

Planning has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to

the City of Sauk Rapids, Minnesota, the same as if it had originally been made a part thereof:

All that part of the Southwest Quarter of the Northwest Quarter (SW1/4 NW1/4) of Section 25, Township 36 North, Range 31 West, Benton County, Minnesota described

as follows: Beginning at the southeast corner of said Southwest Quarter of Northwest Quarter; thence westerly along the south line of said Southwest Quarter, Northwest Quarter a distance of 150.00 feet; thence northerly and parallel to the east line of said Southwest Quarter, Northwest Quarter to its intersection with the centerline of 5th Street South, formerly Benton County Road #46; thence southeasterly along said centerline to its intersection with said east line of Southwest Quarter, Northwest Quarter, thence southerly along said centerline to its intersection with said east line of Southwest Quarter, Northwest Quarter, thence southerly along said east line to the point of beginning, less part previously annexed.

AND

That part of the Southeast Quarter of the Northwest Quarter (SE1/4 NW1/4) of Section 25, Township 36 North, Range 31 West, Benton County, Minnesota, lying West of Minnesota State Highway #10 and South of 5th Street South, formerly Benton County Road #46, less part previously annexed.
