WHEREAS, the City of Center City has entered into an Agreement for Orderly Annexation dated January 5, 1988, which agreement was amended on November 1, 1988 permitting the annexation of lots presently outside of the municipal boundaries to join the city, being contained in the plat of Cedar Point as recorded in the office of the County Recorder of Chisago County, MN and

WHEREAS, the City has received authorization from the Chisago Lake Township Board to orderly annex Lots 6, 7, 8, 11, 12, and 17 of the plat of Cedar Point to be annexed to the City of Center City, and

WHEREAS, pursuant to said orderly annexation agreements, said lot may be annexed upon the adoption of a resolution approving same, and

WHEREAS, under the terms of said agreements and in the interests of the city, it is appropriate that said described lot be annexed to Center City;

NOW THEREFORE BE IT RESOLVED, that the City Council of Center City hereby approves the annexation of Lots 6, 7, 8, 11, 12, and 17 of the plat of Cedar Point. The City Clerk is authorized and directed to do all things and undertake all acts necessary to complete the formal annexation of said lot as is required by law, including but not limited to, forwarding a certified copy of this resolution to the Town of Chisago Lake, the Chisago County Auditor and the Minnesota Municipal Board.

Councilperson <u>Mark Wolcott</u> seconded the motion for the adoption of the above resolution, whereupon same was put to vote.


