**ORDER AMENDING THE
ORDER APPROVING ANNEXATION**

On May 13, 2022, an ORDER APPROVING ANNEXATION (May 13, 2022 Order) was issued for the annexation of certain real property to the City of Madison (City) from Madison Township (Township) pursuant to Minn. Stat. § 414.0325 (2022).

On August 29, 2022, the Office of Administrative Hearings was advised that the legal description in the May 13, 2022 Order contained an error.

An Amended Joint Resolution to correct the legal description in the May 13, 2022 Order was adopted by the City on January 9, 2023, and the Township on January 6, 2023.

Based upon a review of the Amended Joint Resolution, the Administrative Law Judge makes the following:

ORDER

1. The legal description in the May 13, 2022 Order is amended to read as follows:

Lot 16, Lot 17, Lot 18, Lot 19, Lot 20, and Lot 21 of the record plat entitled KJOSNESS ADDITION, on file in the office of the Lac Qui Parle County Recorder, Minnesota.

EXCEPT that part lying northerly and easterly of the following described line: Commencing at the northwest corner of Lot 21 of said record plat entitled KJOSNESS ADDITION;- thence on an assumed bearing of North 89 degrees 27 minutes 00 seconds East, along the north line of said record plat entitled KJOSNESS ADDITION, a distance of 293.00 feet to the point of beginning of the line to be described; thence on a bearing of South 0 degrees 05 minutes 00 seconds East a distance of 410.00 feet; thence on a bearing of North 89 degrees 27 minutes 00 seconds East a distance of 881.81 feet to the east line of said Lot 16, where said line terminates. Said tract contains 28.7 acres more or less.

AND

That part of the Northeast Quarter of the Northwest Quarter (NE1/4NW1/4) of Section Twenty (20), Township One hundred eighteen (118) North, Range Forty-four (44) West, Lac qui Parle County, Minnesota, described as follows:

Beginning at the northeast corner of the Northwest Quarter (NW1/4); thence South 00 degrees 00 minutes 36 seconds East, assumed bearing along the east line of the said Northwest Quarter (NW1/4) a distance of 719.74 feet; thence South 89 degrees 59 minutes 24 seconds West a distance of 594.84 feet; thence North 01 degrees 54 minutes 02 seconds West a distance of 720.44 feet to a point on the north line of the said Northwest Quarter (NW1/4); thence North 89 degrees 57 minutes 56 seconds East, along said north line, a distance of 618.41 feet to the said point of beginning. Said tract contains 10.02 acres more or less.
