

## IN THE MATTER OF THE ORDERLY ANNEXATION BETWEEN THE CITY OF IVANHOE AND ROYAL TOWNSHIP PURSUANT TO MINNESOTA STATUTES SECTION 414.0325

**WHEREAS,** a request from the property owner of the area proposed for designation and immediate annexation was received; and

**WHEREAS,** the City of Ivanhoe and Royal Township jointly agree to designate and request the immediate annexation of the following described land located within Royal Township to the City of Ivanhoe, County of Lincoln, Minnesota;

See attached Exhibit "A" referred to as Certificate of Survey; and

WHEREAS, the City of Ivanhoe and Royal Township are in agreement as to the orderly annexation of the unincorporated land described; and

**WHEREAS,** Minnesota Statutes Section 414.0325 provides a procedure whereby the City of Ivanhoe and Royal Township may agree on a process of orderly annexation of a designated area; and

**WHEREAS,** the City of Ivanhoe and Royal Township have agreed to all the terms & conditions for the annexation of the above-described lands; and the signatories hereto agree that no alteration of the designated area is appropriate and no consideration by the Chief Administrative Law Judge is necessary. The Chief Administrative Law Judge may review and comment, but shall within thirty (30) days, order the annexation in accordance with the terms of the resolution.

**NOW, THEREFORE, BE IT RESOLVED,** jointly by the City Council of the City of Ivanhoe and the Township Board of Royal Township as follows:

1. Property. That the following described land is subject to orderly annexation pursuant to Minnesota Statutes Section 414.0325, and that the parties hereto designate the area for orderly annexation; and agree that the land be immediately annexed:

See attached Exhibit "A" referred to as Certificate of Survey.

- Acreage/Population/Usage. That the orderly annexation area consists of approximately 4.85 acres, the population in the area is unoccupied, and the land use type has been agricultural.
- 3. Jurisdiction. That Royal Township and the City of Ivanhoe, by submission of this joint resolution to the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, confers jurisdiction upon the Chief Administrative Law Judge so as to accomplish said orderly annexation in accordance with the terms of this resolution.
- 4a. Municipal Reimbursement. The property is tax exempt and does not generate taxes and therefore the parties agree to no reimbursement.

- 4b. Assessments & Debt. That pursuant to Minnesota Statutes Section 414.036 with respect to any special assessment assigned by the Township prior to the annexation and attributable to the property to be annexed, but for which no special assessments are outstanding, for the area legally described (herein or attached exhibit) there are (1) no special assessments or debts.
- 5. Review & Comment. The City of Ivanhoe and Royal Township agree that upon receipt of this resolution, passed and adopted by each party, the Chief Administrative Law Judge may review and comment, but shall within thirty (30) days, order the annexation with the terms of the resolution.





## EXHIBIT "A"

All that part of the Southwest Quarter of Section 34, Township 112 North Range 45 West, Lincoln County, Minnesota, being more particularly described as follows:

Beginning at a point on the west line of the alley as shown on the plat of "Blocks 16 to 27 Inclusive to the Town of Ivanhoe", said point being the on the westerly extension of the north line of Lot 3 of Block 21 in said "Blocks 16 to 27 Inclusive to the Town of Ivanhoe", thence South 00 degrees 09 minutes 07 seconds West, bearing based on Lincoln County Coordinate System (1996 Adj.), along said west alley line, a distance of 450.00 feet; thence North 89 degrees 54 minutes 52 seconds West a distance of 572.35 feet; thence North 24 degrees 38 minutes 51 seconds East a distance of 494.77 feet, to a point on the westerly extension of the north line of Lot 3 of Block 21 in said "Blocks 16 to 27 Inclusive to the Town of Ivanhoe"; thence South 89 degrees 54 minutes 52 seconds East, along said westerly extension, a distance of 367.20 feet to the point of beginning.
