RESOLUTION AMENDING JOINT RESOLUTION FOR THE ORDERLY ANNEXATION BETWEEN THE TOWNSHIP OF ROSENDALE AND THE CITY OF ST. JAMES, WATONWAN COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES SECTION 414.0325, SUBD 1.

WHEREAS, the town of St. James and Rosendale Township along with the City of St. James, Minnesota, entered into a joint resolution of orderly annexation on August 15, 1989; and

WHEREAS, the City of St. James has entered into an agreement to purchase certain property described in Exhibit "A" attached hereto and incorporated herein by reference and is desirous of annexing said property, it being located within the orderly annexation area as designated in said resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES AND THE TOWN BOARD OF ROSENDALE TOWNSHIP that they jointly agree that the joint resolution between the Township of Rosendale and the City of St. James designated for an area of annexation dated August 15, 1989, be amended to include the following:

Both the Township of Rosendale and the City of St. James agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of this resolution, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation to the City of St. James with the following described property in accordance with the terms of the joint resolution.
