RESOLUTION AMENDING JOINT RESOLUTION FOR ORDERLY ANNEXATION BETWEEN THE TOWN OF ROSENDALE AND THE CITY OF ST. JAMES, WATONWAN COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES SECTION 414.0325, SUBD. 1

TO: OFFICE OF ADMINISTRATIVE HEARINGS, MUNICIPAL BOUNDARY ADJUSTMENT UNIT, P.O. BOX 64620, ST. PAUL, MINNESOTA 55164-0620

WHEREAS, the Towns of St. James and Rosendale Township along with

the City of St. James, Minnesota, entered into a joint resolution of orderly annexation on

August 15, 1989; and

WHEREAS, the City of St. James has received a Petition from the

landowner requesting that the following described property be annexed to the City of St.

James:

That part of Government Lot Four (4), in Section Eighteen (18), Township One Hundred Six (106), Range Thirty-one (31), Watonwan County, Minnesota, described as follows: Commencing at a point 1272.3 feet South and 33 feet East of the Northwest corner of said Section Eighteen (18), thence North parallel with West section line of said Section Eighteen (18), a distance of 249.5 feet, thence East at right angle a distance of 110 feet to the right-of-way of Minneapolis and St. Louis Railway, thence Southwest along the Minneapolis and St. Louis right-of-way to the place of beginning.

Said property is urban and residential in character and the City of St. James is desirous

of annexing said property, being located within the orderly annexation areas designated

in said Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE

CITY OF ST. JAMES AND THE TOWN BOARD OF ROSENDALE that they hereby

jointly agree that the joint resolution between the Town of Rosendale and the City of St.

James designated an area for annexation dated August 15, 1989, be amended to include the following:

Both the Town of Rosendale and the City of St. James agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of this Resolution, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation to the City of St. James with the following described property in accordance with the terms of the joint resolution:

That part of Government Lot Four (4), in Section Eighteen (18), Township One Hundred Six (106), Range Thirty-one (31), Watonwan County, Minnesota, described as follows: Commencing at a point 1272.3 feet South and 33 feet East of the Northwest corner of said Section Eighteen (18), thence North parallel with West section line of said Section Eighteen (18), a distance of 249.5 feet, thence East at right angle a distance of 110 feet to the right-ofway of Minneapolis and St. Louis Railway, thence Southwest along the Minneapolis and St. Louis right-of-way to the place of beginning.






