IN THE MATTER OF THE JOINT RESOLUTION OF THE TOWN OF KEGO AND THE CITY OF LONGVILLE, CASS COUNTY, MINNESOTA, DESIGNATING AN UNINCORPORATED AREA AS IN NEED OF ORDERLY ANNEXATION AND CONFERRING JURISDICTION OVER SAID AREA TO THE MINNESOTA MUNICIPAL BOARD PURSUANT TO MS 414.0325.

FOR ORDERLY ANNEXATION

The Town of Kego and the City of Longville hereby jointly agree to the following:

1. That the following described area in Kego Township is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for orderly annexation, to wit:

That part of Government Lot Five (5), Section Thirtyfour (34), Township One Hundred Forty-one (141), Range Twenty-eight (28), Cass County, Minnesota, lying easterly of Minnesota Highway #84, EXCEPT the following described tracts: Commencing at the southeast corner of said Government Lot 5, thence North 89°00'50" West 377.82 feet along the south line of said Government Lot 5, thence North 176.90 feet to the point of beginning of the land to be described, thence North 28°49'00" East 270.00 feet; thence North 61°11'00" West 184.00 feet to the centerline of said Highway #84; thence Southwesterly along said centerline 270.00 feet to the point of intersection with a line that bears North 61°11'00" West from the point of beginning, thence South 61°11'00" East 180.00 feet to the point of beginning. Containing 40,000 square feet, more or less, AND Commencing at the southeast corner of said Government Lot 5; thence North 88°34'50" West 347.15 feet along the south line of said Government Lot 5 to the point of beginning of the land to be described; thence North 157.93 feet; thence North 61°11'00" West 215.00 feet to the centerline of said Minnesota Highway #84, thence Southwesterly along said centerline 265.27 feet to said south line of Government Lot 5, thence South 88°34'50" East 261.22 feet to the point of beginning, containing 40,000 square feet, more or less, lying easterly of the easterly right-of-way line of said Minnesota Highway #84.

2. That the Town Board of the Township of Kego in the City Council of the City of Longville, upon passage of this resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in the agreement.

3. That these certain properties abut the City of Longville and the annexation is in the best interests of the area proposed for annexation.

4. Both the Town of Kego and the City of Longville agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary.

Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.


