AND THE TOWN OF KEGO PURSUANT TO )
MINNESOTA STATUTES 414 )

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Longville and the Town of Kego and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Longville pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 18, 1991, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Longville, Minnesota, the same as if it had originally been made a part thereof:

That part of Government Lot Five (5), Section Thirty-four (34), Township One Hundred Forty-one (141), Range Twenty-eight (28), Cass County, Minnesota, lying easterly of Minnesota Highway #84, EXCEPT the following described tracts: Commencing at the southeast corner of said Government Lot 5, thence North 89°00'50" West 377.82 feet along

the south line of said Government Lot 5, thence North 176.90 feet to the point of beginning of the land to be described, thence North 28°49'00" East 270.00 feet; thence North 61°11'00" West 184.00 feet to the centerline of said Highway #84; thence Southwesterly along said centerline 270.00 feet to the point of intersection with a line that bears North 61°11'00" West from the point of beginning, thence South 61°11'00" East 180.00 feet to the point of beginning. Containing 40,000 square feet, more or less, AND Commencing at the southeast corner of said Government Lot 5; thence North 88°34'50" West 347.15 feet along the south line of said Government Lot 5 to the point of beginning of the land to be described; thence North 157.93 feet; thence North 61°11'00" West 215.00 feet to the centerline of said Minnesota Highway #84, thence Southwesterly along said centerline 265.27 feet to said south line of Government Lot 5, thence South 88°34'50" East 261.22 feet to the point of beginning, containing 40,000 square feet, more or less, lying easterly of the easterly right-of-way line of said Minnesota Highway #84.

IT IS FURTHER ORDERED: That the effective date of this order is March 18, 1991.
