IN THE MATTER OF THE JOINT RESOLUTION OF THE CITY OF NASHWAUK AND THE TOWN OF NASHWAUK DESIGNATING AN UNINCORPORATED AREA AS IN NEED OF ORDERLY ANNEXATION AND CONFERRING JURISDICTION OVER SAID AREA TO THE MINNESOTA MUNICIPAL BOARD PURSUANT TO MINN. STAT. 414.0325

JOINT RESOLUTION FOR ORDERLY ANNEXATION

The Township of Nashwauk and the City of Nashwauk hereby jointly agree to the following:

1. That the following described area in Nashwauk Township is subject to orderly annexation pursuant Minnesota Statutes 414.0325.

## Section 33, Township 57 North, Range 22 West:

Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$  SW $\frac{1}{4}$ ) North of Trunk Highway 169.

Southwest Quarter of the Northwest Quarter (SW4 NW4).

Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  NW $\frac{1}{4}$ ) South of Abandoned Trunk Highway 169.

Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$  SW $\frac{1}{4}$ ) North of Trunk Highway 169.

Southeast Quarter of the Northwest Quarter (SE4 NW4).

Northeast Quarter of the Northwest Quarter (NE<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>2</sub>) South of Abandoned Trunk Highway 169.

Northwest Quarter of the Southeast Quarter (NW1 SE1) North of Trunk Highway 169.

Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$  NE $\frac{1}{4}$ ) less Obrien Lake.

Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$  NE $\frac{1}{4}$ ) South of Abandoned Trunk Highway 169 and less Obrien Lake.

# Section 28, Township 57 North, Range 22 West:

Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ) South of Abandoned Trunk Highway 169, less Obrien Lake.

2. That the Town Board of Nashwauk Township, and the City Council of the City of Nashwauk, upon passage and adoption of this resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in this Resolution.

3. That these certain properties which abut the City of Nashwauk are presently urban and suburban in nature or about to become so. Further, the City of Nashwauk is capable of providing services to this area within a reasonable time, and the annexation is in the best interest of the area proposed for annexation. Therefore, these properties would be immediately annexed to the City of Nashwauk, to-wit:

### Section 33, Township 57 North, Range 22 West:

Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$  SW $\frac{1}{4}$ ) North of Trunk Highway 169.

Southwest Quarter of the Northwest Quarter (SW4 NW4).

Northwest Quarter of the Northwest Quarter ( $NW_{\frac{1}{4}}$   $NW_{\frac{1}{4}}$ ) South of Abandoned Trunk Highway 169.

Northeast Quarter of the Southwest Quarter ( $NE\frac{1}{4}$   $SW\frac{1}{4}$ ) North of Trunk Highway 169.

Southeast Quarter of the Northwest Quarter ( $SE_{\frac{1}{4}}$   $NW_{\frac{1}{4}}$ ).

Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$  NW $\frac{1}{4}$ ) South of Abandoned Trunk Highway 169.

Northwest Quarter of the Southeast Quarter ( $NW_{\frac{1}{4}}$   $SE_{\frac{1}{4}}$ ) North of Trunk Highway 169.

Southwest Quarter of the Northeast Quarter (SW4 NE4) less Obrien Lake.


Northwest Quarter of the Northeast Quarter (NW1 NE1) South of Abandoned Trunk Highway 169 and less Obrien Lake.

#### Section 28, Township 57 North, Range 22 West:

Southwest Quarter of the Southeast Quarter (SW\(\frac{1}{4}\) South of Abandoned Trunk Highway 169, less Obrien Lake.

4. Both the City of Nashwauk and the Town of Nashwauk agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.
