MINNESOTA STATUTES 414)

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Big Lake and the Town of Big Lake; and

WHEREAS, a resolution was received from the City of Big Lake indicating their desire that certain property be annexed to the City of Big Lake pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on December 11, 2003, the Acting Director has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Big Lake, Minnesota, the same as if it had originally been made a part thereof:

TRACT 1 (approximately 1.5 acres)
Parcel Identification No. 10-121-4405

A one and one-half acre tract in the S ½ SE ¼ of Sec. 21, Twp. 33, Rge 27, described

as follows, to-wit:

Commencing at a point with the South line of Highway No. 10 intersects the East line of County Road; thence East along the South line of Highway No. 10 a distance of 336 feet; thence South at right angles and parallel to the East line of the S $\frac{1}{2}$ SE $\frac{1}{4}$, a distance of 183 feet; thence at right angles 336 feet to the East line of Township Road (172nd Street); thence North on said Township Road to the point of beginning, Sherburne County, Minnesota.

TRACT 2 (approximately 0.18 acres)


Parcel Identification No. 10-121-4401

That part of the S $\frac{1}{2}$ SE $\frac{1}{4}$ of Sec. 21, Twp. 33, Rge. 27, described as follows, to-wit:

Commencing at a point where the South line of Highway No. 10 intersects the East line of Township Road (172nd Street); thence East along the South line of Highway No. 10 a distance of 336 feet; thence South at right angles and parallel to the East line of the S $\frac{1}{2}$ SE $\frac{1}{4}$, a distance of 183 feet; the actual point of beginning of the tract to be described; thence West and parallel to the South right-of-way at said U.S. Highway No. 10, a distance of 96 feet; thence South at right angles and parallel to the East line of the S $\frac{1}{2}$ SE $\frac{1}{4}$, a distance of 80 feet; thence East at right angles and parallel with the South right-of-way line of U.S. Highway No. 10, a distance of 96 feet; thence North at right angles, parallel to the East line of the S $\frac{1}{2}$ SE $\frac{1}{4}$, a distance of 80 feet to the point of beginning, Sherburne County, Minnesota.
