**JOINT RESOLUTION CONCERNING
ORDERLY ANNEXATION OF RIGHTS OF WAY**

WHEREAS, the City of Sartell, a Minnesota municipality (hereinafter referred to as the "City"), and the Town of LeSauk, a Minnesota town (hereinafter referred to as the "Town"), adopt the following joint resolution; and


WHEREAS, the City and Town had previously adopted an orderly annexation agreement, OA-276; and

WHEREAS, the land described is included in the existing orderly annexation agreement.

THEREFORE, the City and Town (hereinafter jointly referred to as the "parties") hereby jointly resolve:

1. That the area described in the attached Exhibit A (hereinafter referred to as the "designated area"), is hereby designated in need of orderly annexation.
2. That jurisdiction over the annexation of the designated area is hereby conferred on the Municipal Board.
3. That no consideration of the annexation of the designated area by the Board is necessary.
4. That the parties request the Board to immediately order the annexation of the designated area by the City pursuant to and in accordance with the provisions of MN State Statutes 414.0325.
5. That the Board may review and comment upon the area proposed for annexation, but may not alter the boundaries and shall within thirty (30) days, order the annexation in accordance with the terms of this Resolution.







The north half of Terry Lane, a dedicated thoroughfare in MEYER PARK PLAT 2, a duly recorded plat on file and of record in the Office of the County Recorder, Stearns County, Minnesota that lies westerly of the west line of the most easterly 66.00 feet of Lot 13, Block 1, MEYER PARK PLAT 3, according to the plat thereof, on file and of record in the Office of the County Recorder, Stearns County, Minnesota extended southerly to the centerline of said Terry Lane. Together with the south half of said Terry Lane that lies adjacent to Lots 5, 6 and 7 of Block 1, said MEYER PARK PLAT 2. Containing 0.4 of an acre, more or less.

345TH STREET (2 1/2 STREET)

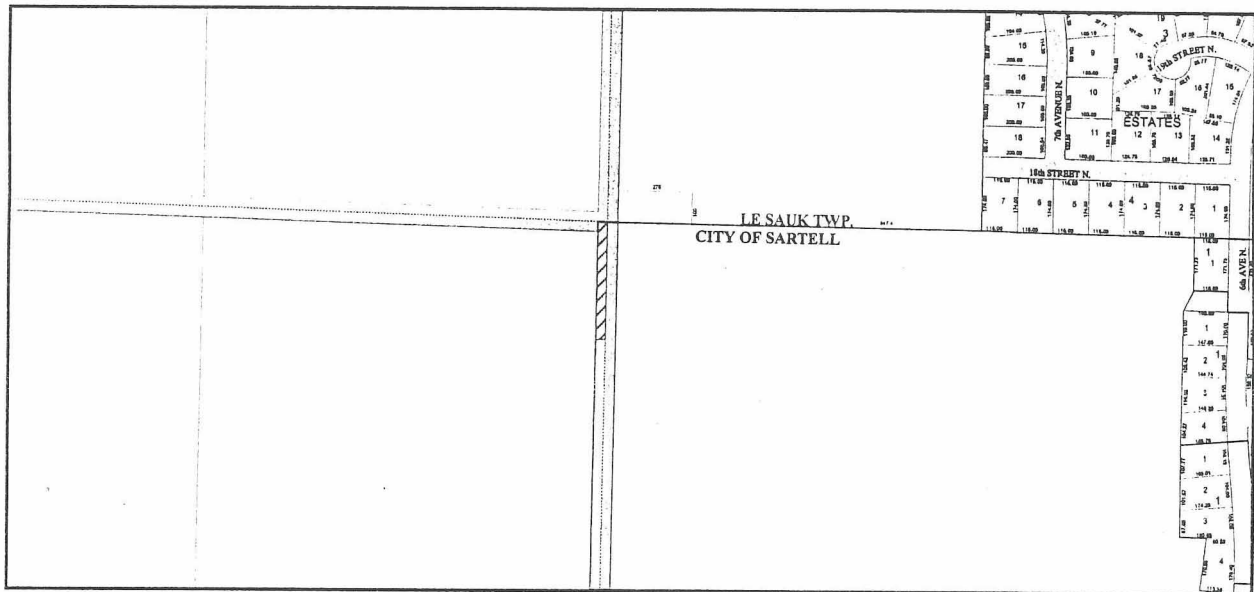

Containing 3.0 acres, more or less.

55TH AVENUE NORTH (PINE CONE ROAD)

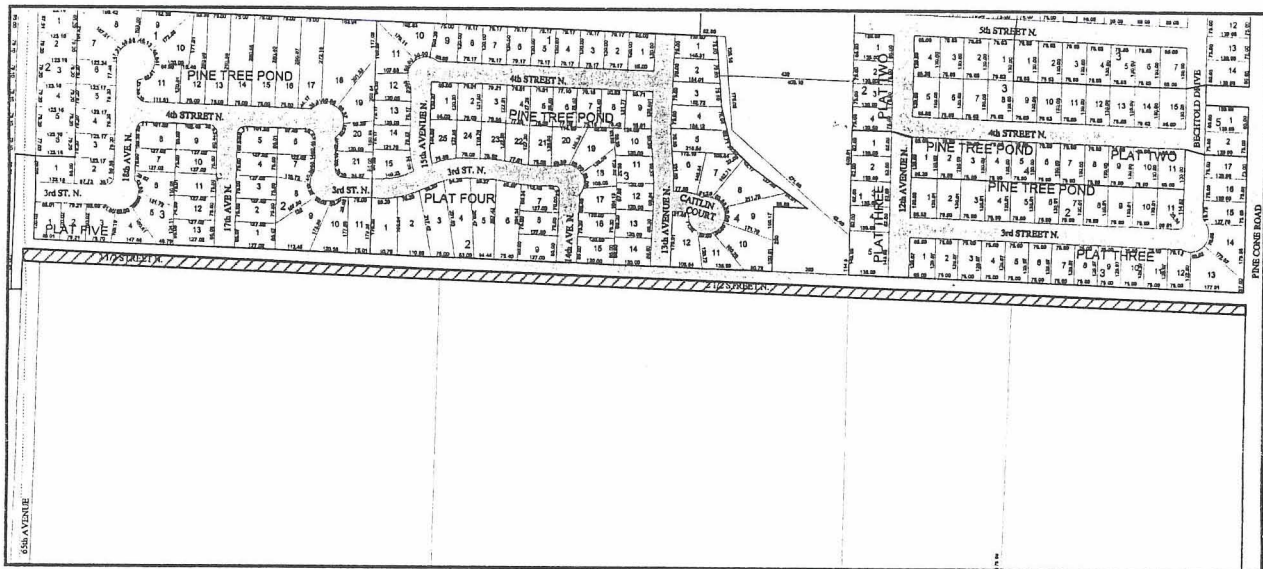



55th Avenue North (Pine Cone Road)
