**JOINT RESOLUTION APPROVING ANNEXATION**

**WHEREAS,** a joint resolution for orderly annexation was adopted by the City of Sartell and the Town of LeSauk and duly accepted by the Minnesota Municipal Board; and

**WHEREAS,** said joint resolution requested that certain property be annexed to the City of Sartell pursuant to M.S. 414.0325, Subdivision 1; and

**WHEREAS,** M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

**WHEREAS,** a joint public hearing of the Town Board and City Council was held on December 10, 1997, at which time all persons present wishing to be heard regarding the matter were given an opportunity to be heard and written comments were also accepted.

**NOW, THEREFORE, BE IT RESOLVED:** That the following described property is hereby annexed to the City of Sartell, Minnesota, the same as if it had originally been made a part thereof:

Lots 1, 2 and 3 of WEINAND'S ADDITION, according to the plat thereof, on file and of record in the Office of the County Recorder, Stearns County, Minnesota.

AND

Lots 1, 2 and 3 of Block 1 and Lots 1, 2 and 3 of Block 4, WEINAND'S ADDITION PLAT 2, according to the plat thereof, on file and of record in the Office of the County Recorder, Stearns County, Minnesota, together with the public street dedicated on said WEINAND'S ADDITION PLAT 2 that lies easterly of the following described line: Beginning at the northwest corner of said Lot 3, Block 4; thence northwesterly to the southwest corner of said Lot 3, Block 1 and said line terminating thereat.

Containing 3.7 acres, more or less.

**BE IT FURTHER RESOLVED:** That said property is being annexed to the City of Sartell under zoning classification of R-1, Single Family Residence District, and has a current population of 20.
