AGREEMENT BETWEEN THE CITY OF SARTELL)	<u>ORDER</u>
AND THE TOWN OF LESAUK PURSUANT TO)	
MINNESOTA STATUTES 414)	

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Sartell and the Town of LeSauk; and

WHEREAS, a resolution was received from the City of Sartell indicating their desire that certain property be annexed to the City of Sartell pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on April 6, 1998, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to

the City of Sartell, Minnesota, the same as if it had originally been made a part thereof:

Lots 1,2 and 3 of Weinand's Addition, according to the plat thereof, on file

and of record in the office of the County Recorder, Stearns County, Minnesota. AND Lots 1,2 and 3 of Block 1 and Lots 1,2 and 3 of Block 4, Weinand's Addition Plat 2, according to the plat thereof, on file and of record in the office of the County Recorder, Stearns County, Minnesota, together with the public street dedicated on said Weinand's Addition Plat 2 that lies easterly of the following described line:

Beginning at the northwest corner of said Lot 3, Block 4; thence northwesterly to the southwest corner of said Lot 3, Block 1 and said line terminating thereat. Containing 3.7 acres, more or less.

More particularly described as follows:

Lots 1, 2 and 3 of WEINAND'S ADDITION, according to the plat thereof, on file and of record in the Office of the County Recorder, Stearns County, Minnesota. AND Lots 1, 2 and 3 of Block 1 and Lots 1, 2 and 3 of Block 4. WEINAND'S ADDITION PLAT 2, according to the plat thereof, on file and of record in the Office of the County Recorder, Stearns County, Minnesota, together with the public street dedicated on said WEINAND'S ADDITION PLAT 2 that lies easterly of the following described line: Beginning at the northwest corner of said Lot 3, Block 4; thence northwesterly of the southwest corner of said Lot 3, Block 1 and said line terminating thereat. Containing 3.7 acres, more or less.

Less and except that part of Government Lot 2, Section 16, Township 125 North, Range 28 West, Stearns County, Minnesota that lies northerly of the following described line: Commencing at a point on the easterly side of Lot 1, WEINAND'S ADDITION, which point is located as being 18.46 feet southerly (and measured along the right of way of the county road) of the northeast corner of said Lot 1; running thence westerly directly toward the northwest corner of said Government Lot 2 to the line between Lots 1 and 2 in Block 1 of WEINAND'S ADDITION PLAT 2; running thence northerly along the east line of said Lot 2 to the north line of said Government Lot 2 and there terminating.


